Under authority granted to me by the Southern California Association of Governments (SCAG) Regional Council, I hereby approve and transmit amendment #25-21 for projects in Los Angeles, Orange, Riverside, San Bernardino and Ventura counties. This amendment:

- Does NOT require a new conformity determination and new regional emissions analysis;
