The Commission directs USAC to open an initial 45-day ECF filing window "as soon as practicable" during which applicants will be able to submit requests for funding for purchases made between July 1, 2021 and June 30, 2022. If there are remaining funds after this initial application window, the Commission may open a second application window for schools and libraries to seek funding for eligible equipment and services purchased from March 1, 2020 to June 30, 2021. However, in the event that demand for prospective support in the first window appears to be far in excess of what is available, the Commission may consider opening a second prospective window before opening an application window to fund previous purchases. (Note that this is a change (requested by Commissioner Carr) from the draft Report and Order, which had prioritized previous purchases over prospective purchases.) From June 29 to August 13, eligible schools and libraries can submit requests for funding to purchase eligible equipment and services for the 2021-22 school year.

Eligible uses include educational technology (hardware, software, and connectivity). California also has been allocated \$181,312,003 for Emergency Assistance to Non-Public Schools (EANS). Congress instructed the equal services requirements that typically apply to elementary and secondary formula grant programs. EANS I applications are closed but EANS II funding has not yet been disbursed. Under EANS, LEAs are not required to provide equitable services for funds received under the ARP Act, though equitable services requirements continue to apply to CARES Act programs. At least 80% of the amount of the grants made under the Pilot Program will be made to HBCUs and at least 20% of the amount of the grants made under the Pilot Program are made to HBCUs, TCUs, or MSIs. The remainder can go to consortia including Minority Serving Institutions (MSIs) as well as a minority business enterprise or a 501(c)(3) organization. Preference is given to projects that prioritize students who are eligible to receive Federal Pell Grants, receive other need-based financial aid, or are qualifying low-income consumers. The goal is to facilitate educational instruction and learning, including through remote instruction, as well as potentially minority business enterprise or operation of 501(c)(3) organizations

The Emergency Broadband Benefit is limited to one monthly service discount and one device discount per household.
