Public Notice is hereby given that the SCAG RHNA Appeals Board will conduct a public hearing on the dates identified above to hear appeals of draft regional housing need allocations distributed to local

jurisdictions as part of the Draft RHNA Allocation Plan released by SCAG on September 4, 2020. **Any jurisdiction that has filed an appeal should refer to the schedule for the specific date when its appeal will be heard.** These public hearings will be held as part of SCAG's effort to prepare a Final RHNA Plan for the SCAG region in accordance with state law.

This public hearing is being held pursuant to Government Code Section 65584.05(d) and will provide an opportunity for jurisdictions that filed appeals to provide testimony before the RHNA Appeals Board as part of the Board's determination on appeals. In addition, the public hearings are part of SCAG's efforts relating to the 6th Cycle RHNA process and preparing a Final RHNA Allocation Plan as required by the State in order for local jurisdictions to prepare updated General Plan Housing Elements. Each hearing is considered to be a continuation of the prior appeals hearing.
