Subject: Regional Early Action Planning Grant 2021 (REAP 2.0): Program Budget

Update

RECOMMENDED ACTION:

Information Only - No Action Required

STRATEGIC PRIORITIES:

This item supports the following Strategic Priority 1: Establish and implement a regional vision for a sustainable future. 5: Secure and optimize diverse funding sources to support regional priorities.

EXECUTIVE SUMMARY:

Resolution 22-649-1 authorizes SCAG to receive and administer \$246,024,084.00 in Regional Early Action Planning Grant Program of 2021 (REAP 2.0) funds from the State of California. The Governor's January 2024 budget proposed a 50% reduction (\$300 million) to the REAP Program across the state. Given the magnitude of the reduction SCAG placed a hold on sub-allocation programs and along with partners engaged in a comprehensive advocacy effort to restore funding. SCAG's advocacy cited how the cut would severely impact cities and counties' ability to address the housing crisis and adversely affect the funding dedicated to projects throughout the SCAG region.

As a result of the region's successful advocacy, the recently adopted state budget restores the majority of the funding and only cuts \$30 million from the State's REAP 2.0 program. HCD has informed SCAG and other MPOs that reductions are to be shared evenly across the program, meaning SCAG's award has been reduced by 5.9%, approximately \$14.5 million. This report provides the revised SCAG REAP 2.0 Program budget, timeline, and program, reflecting the 5.9% reduction and its impact.

BACKGROUND:

The REAP 2.0 program was established as part of the 2021 California Comeback Plan under AB 140. REAP 2.0 builds on the success of Regional Early Action Planning Grant Program of 2019 (REAP 1.0) and expands the program focus by integrating housing and climate goals, and allows for broader





planning and implementation investments, including infrastructure investments supporting infill development to facilitate housing supply, choice, and affordability.

Major investments in program development and prioritization of projects have resulted in SCAG's development of a comprehensive REAP 2.0 program that combines coordinated and transformative actions aligning transportation and housing development by investing in innovative finance, land use, and transportation strategies.

On January 10, 2024, Governor Gavin Newsom announced a proposed budget that would cut \$1.2 billion in funding for housing programs, including \$300 million for the Regional Early Action Plan (REAP 2.0) program. SCAG issued a hold on suballocation programs, while working to assess the impacts of the proposed cut and partnering with key stakeholders to use the state's budget approval process to advocate for the protection of critical housing programs funded by REAP 2.0.

Governor Newsom's January 10, 2024 budget proposal served as the first step of a lengthy budget process. The State Legislature was able to negotiate an agreement with the Governor, and both chambers passed a balanced budget bill as mandated by the state constitution. The Governor signed the budget into law on June 29, 2024. The Legislature has the ability to pass junior budget bills and budget trailer bills until August 31, 2024, the last day on which any bill may be passed. Then, the Governor will have until September 30, 2024, to sign or veto any remaining bills, including budget-related bills, on his desk.

ADVOCACY

Immediately following the release of the Governor's January Budget, SCAG's advocacy team sprang into action. SCAG wrote an official budget letter responding to the Governor's January Budget that was delivered to Assembly Speaker Robert Rivas (D-Hollister), Senate President Pro Tem Toni Atkins (D-San Diego), Assembly Budget Committee Chair Jesse Gabriel (D-Van Nuys), and Senate Budget and Fiscal Review Committee Chair Nancy Skinner (D-Berkeley). The letter outlined SCAG's concerns with the devastating cuts proposed to the REAP 2.0 program. The letter asked Legislative leaders to reject this proposal, as well as proposals to cut \$200 million from the State's Active Transportation Program and cut \$200 million from the Infill Infrastructure Grant program. The letter was further shared with every member of the Southern California Legislative Delegation and SCAG partner organizations, including the California Association of Councils of Governments, California State Association of Counties, League of California Cities, and our sister Metropolitan Planning Organizations.

SCAG's lobbyists, Cruz Strategies, provided public comment in support of the REAP 2.0 program at Assembly and Senate budget committee hearings on January 23, 2024. During the Assembly Budget Committee hearing, Assemblymember Steve Bennett (D-Ventura), who is also Chair of the Sub-Committee No. 4 on Climate Crisis, Resources, Energy, and Transportation spoke in defense of the





REAP 2.0 program, noting the significant benefits the program provides, especially for the communities in his district.

SCAG was able to engage our member and partner organizations to grow the coalition supporting the REAP 2.0 program. SCAG, with the help of this coalition, successfully advocated to protect the majority of these funds, resulting in a cut to the State's program of \$30 million, as opposed to the proposed \$300 million cut in the January budget package.

PROGRAM ADMINISTRATION & DELIVERY

SCAG staff, under the direction of the policy committees, the EAC, and the RC, conducted an extensive engagement process to develop a comprehensive REAP 2.0 program based on stakeholder input. SCAG's REAP 2.0 program is focused on addressing key issues contributing to the housing crisis: scarcity of developable land, insufficient and costly utility and transportation public infrastructure, and lack of capacity building financing tools. Ultimately, SCAG is piloting solutions locally that can be scaled across the region.

SCAG committed the entire \$246 million award from the State. Advanced funding of \$24.6 million was authorized to support outreach and program development, including hiring required limited-term staff and consultants. To date, SCAG awarded \$192.7M to 100 projects. The remaining funding was allocated to SCAG led programs and program administration.

The \$14.5 million reduction to SCAG's allocation will not require restructuring the full program and will not require eliminating or reducing any of the competitive formula-based sub-allocation programs. However, the revised budget will reflect a reduction in the SCAG-led regional programs and services originally planned to be supported by REAP 2.0 to both account for the budget cut as well as the shortened time-frame for program delivery.

PROGRAM BUDGET AND TIMELINE ADJUSTMENTS

The program budget will be amended with HCD in the coming months, as well as approved by the Regional Council through the regular budget process. Adjustments are anticipated to include the following reductions:

- The \$15 million Regional Pilot Initiatives program, a non-sub-allocated effort, will be removed from the SCAG REAP 2.0 program and instead funded through the federal Carbon Reduction Program (CRP) funding allocated to SCAG.
- The proposed Data Platform Expansion will be more limited, focusing on the completion of StreetLight Insight Web App Big Data Platform, which was initiated prior to the pause. The down-scoping will result in a savings of almost \$1 million (\$975,000) and ensure work can be completed within grant timelines.



• In light of the 6-month program delay, SCAG led outreach and technical assistance around fellowships, data, GIS, and performance dashboards will no longer be funded through REAP 2.0, resulting in an additional \$1.5 million budget reduction.

These actions will allow SCAG to fully fund all sub-allocated programs which were identified as a high priority when communicating possible paths forward, while establishing a reserve to provide the board with flexibility to address any future and unforeseen needs.

The timeline for the program restart is as follows:

- June-July 2024
 - The final State budget was approved
 - HCD provided SCAG with final REAP 2 allocation of \$231.5M
 - SCAG staff sent out program and project level restart communication to grantees and rescinded the 'stop work order'
- August -December 2024
 - SCAG staff will develop and finalize scopes of work with awardees (100 projects)
 - SCAG staff will distribute MOU templates to awardees
 - SCAG staff will initiate procurements in partnership with awardees upon approval of scopes of work
 - SCAG's formal FY2025 Budget Amendment 1 will be presented to EAC and RC for approval and adoption, including revised REAP 2.0 amounts
 - Execute MOUs

Notices have gone out to partners awarded funds under SCAG's sub-allocation programs rescinding the Executive Director's pause of all significant REAP 2.0 activities, allowing the program work to proceed. The current expenditure deadline for the REAP 2.0 program is June 30, 2026. While SCAG will advocate for an extension of time to account for the months on hold, uncertainties remain around REAP 2.0 deadline extensions with the State Legislature.

Listed below is a summary of SCAG's fully funded suballocation programs that support eligible entities in the SCAG region:

• The Sustainable Communities Program - Civic Engagement, Equity and Environmental Justice (SCP CEEEJ) grants prioritize housing planning that aims to close the racial equity gap and include partnerships with community-based organizations. On October 5, 2023, the Regional Council approved funding awards for six Housing and Land Use Strategies projects totaling \$2.3 million, complementing five multi-modal communities projects funded by SB 1 funds in the amount of approximately \$2 million.



- The Sub-Regional Partnership Program 2.0 (SRP 2.0) Program makes \$23 million available to sub-regional partners for eligible activities supporting member jurisdictions with implementing housing element work plans and strategies for increasing affordable housing.
- The County Transportation Commission (CTC) Partnership Program connects infill housing to daily services and increases travel options that support multimodal communities to shift travel modes. On July 6, 2023, the Regional Council approved staff recommendations to fund 33 transformative planning and implementation projects that expand access, increase mobility, and bring jobs and housing closer together to achieve a more sustainable growth pattern across the region. SCAG has executed Memorandums of Understanding (MOUs) with most of the CTCs, and the others are in the process of being executed.
- The Housing Infill on Public and Private Lands (HIPP) Pilot Program makes \$8 million available to support eligible applicants in scaling up development of available land and implementing large corridor-wide or area-wide infill housing policies and initiatives. In October, the Regional Council approved funding recommendations to award 11 projects including site assessments, site inventories, inclusionary housing programs and specific plans that unlock lands for housing with diverse housing types.
- The Notice of Funds Available for Lasting Affordability (NOFA) provides \$45 million to support innovative housing finance, housing trust funds, catalyst funds, and new permanent funding sources. On November 2, 2023, the Regional Council approved funding recommendations for 14 projects.
- The Regional Utilities Supporting Housing (RUSH) program provides \$35 million to focus on investments in utility infrastructure planning and capital improvements that will support jurisdictions in basic utility infrastructure needed for housing: water, wastewater, stormwater management and electricity. On January 4, 2024 the Regional Council awarded funding for 12 projects for a total of \$35 million.

The volume of projects the SCAG staff will administer as part of this restart will require close coordination with awardees and patience. SCAG staff recognizes that this disruption in program delivery has had significant impacts on awarded projects and is assessing opportunities to help awardees rework project scopes to accommodate a shorter implementation timeline. More information on these opportunities and any updates SCAG receives from HCD on the program will be promptly shared with partners.





NEXT STEPS

Staff will return to the Regional Council with an update on HCD's review and approval of the revised program, as well as any other program updates in Fall 2024.

Subject: 2024 Executive/Administration Committee (EAC) Retreat Update

RECOMMENDED ACTION:

That the Executive/Administration Committee (EAC), acting on behalf of the Regional Council, review and finalize the revised 2024 Schedule of Regular Meetings for the EAC, Policy Committees and Regional Council.

STRATEGIC PRIORITIES:

This item supports the following Strategic Priority 1: Establish and implement a regional vision for a sustainable future. 2: Be a cohesive and influential voice for the region.

EXECUTIVE SUMMARY:

From June 27 to 28, 2024, President Curt Hagman convened a retreat for the Executive/ Administration Committee (EAC) to discuss strategic priorities for the upcoming year. The agenda included a review of the Board Employment Classification status; an overview on emerging issues related to Transportation Finance, Housing, and Sustainable Communities Strategy; an evaluation of the 2024 Regional Conference and General Assembly; and discussion related to the 2024-2025 Presidential Priorities and Policy Committee Outlooks for the upcoming year. This report summarizes those discussions and identifies necessary follow-ups.

BACKGROUND:

During the annual EAC Retreat convened by President Hagman from June 27 to 28, the EAC discussed topics related to the Board Employment Classification; emerging issues related to Transportation Finance, Housing, Sustainable Communities Strategy; the 2024 Regional Conference and General Assembly; and the 2024-2025 Presidential Priorities and Policy Committee Outlooks.

Board Employment Classification Update

Jeffery Elder, Chief Counsel, provided an update on the classification of board members as independent contractors versus employees. He explained that an IRS finding regarding Metrolink, which required their board members to transition from 1099 independent contractors to W-2 employees, had prompted SCAG to reassess its own practices. Mr. Elder described the steps taken by SCAG to assess the situation, including seeking multiple legal opinions from outside legal counsel





and surveying MPOs in the state. He explained the Section 530 safe harbor under the Revenue Act of 1978 and detailed how SCAG met the criteria for the exemption. Based on the information presented, staff recommended continuing to treat SCAG's board members as independent contractors, which the EAC agreed with.

Emerging Issues: Transportation Finance, Housing, and Sustainable Communities Strategy

<u>Transportation Finance</u>

Annie Nam, Deputy Director of Transportation Planning, provided an overview of the state's current effort to prepare a transportation needs assessment for the next 10 years, inclusive of climate change impacts, in response to SB 1121. The state's initial 10-year funding shortfall is estimated to be \$200 to \$300 billion. There's an interim report that is currently available for review and the California Transportation Commission staff have held two workshops to date. The focus has been on a core set of principles in addressing revenue needs—to help define **what and why** we need to invest in transportation with a stabilized revenue source.

For additional context, SCAG's assessment of the regional impacts of recent zero-emission vehicle (ZEV) regulations was highlighted with an estimated \$93 billion loss in revenue over the life of Connect SoCal 2024. Staff emphasized that this drop in revenue will have a very real impact on the maintenance of our transportation system, especially for the state of good repair of local streets and roads. Staff reiterated the guiding principles and new funding strategies that were incorporated into Connect SoCal 2024, enabling a \$752 billion financial plan.

The Committee discussion highlighted next steps to advance the revenue conversation, including the need for continued engagement in state processes such as the state's latest road charge pilot program. There was emphasis on continued advocacy for the region's express lane system, which includes better aligning SB 743 implementation with regional plans like Connect SoCal 2024. Further, discussions focused on how transportation funding is becoming increasingly inequitable with growing ZEV penetration and how opportunities to stabilize transportation revenues via a road charge program, can potentially serve to mitigate some of these existing equity challenges.

Housing

Elizabeth Carvajal, Deputy Director of Land Use Planning, provided an overview on the state of housing in the region including housing production, housing element compliance, SCAG funding and technical assistance programs, the State's California's Housing Future 2040: The Next RHNA Report.

Overall, the presentation highlighted that housing production across the region has increased modestly, in line with state housing growth. Of note is that in the last few years, there has been a





noteworthy amount of accessory dwelling unit construction and increase in multi-family unit construction.

Given the importance of local policy that supports housing productions, the presentation touched on the status of housing element compliance and SCAG's housing technical assistance programs. As of June 2024, 27% of the housing elements in the region were not compliant with the majority of those in small jurisdictions (less than 100,000 population) and with 12 of those jurisdictions having median household income of \$50,000 or less.

Funding from the State through REAP 1 has become an inflection point for SCAG as an actor in the housing space. Through the REAP 1 program, SCAG funded over 100 projects and 53 awardees to execute a series of activities that support housing production across the region. These projects have increased the number of policies and programs that support housing, developed pre-approved plans, and significantly expanded the number of elected officials and members of the public who have been engaged on local housing efforts in their communities. A brief overview was also provided on the REAP 2 program and the various efforts that will support housing production through policy, financing and infrastructure planning, and implementation.

Finally, a brief overview was provided on the State's California's Housing Future 2040: The Next RHNA Report. As part of AB 101, HCD was tasked with preparing a report that outlined how to improve the Regional Housing Needs Assessment (RHNA) process. SCAG issued comments to HCD via a comment letter that was submitted in September 2023. The report was released in April 2024 and is organized by method of implementation (legislative changes versus things that HCD can execute administratively) as well as organized by three topic areas of the regional determination process, the COG-led processes such as methodology and appeals, and consistency with the RTP/SCS and growth forecasts. Staff will come to the Community, Economy, and Human Development (CEHD) Policy Committee in the fall to provide a summary of the report and how it does or does not respond to SCAG's comment letter.

Sustainable Communities Strategy

As background for SB 375 Target Update policy discussions to occur at the California Air Resources Board (CARB) this fall, Sarah Jepson, Chief Planning Officer, provided an overview of State policies aimed at reducing greenhouse gas emissions and the progress and challenges the SCAG region has faced in meeting ambitious state goals. Connect SoCal 2024, SCAG's most recently adopted Regional Transportation Plan/Sustainable Communities Strategy, has been submitted to the CARB for confirmation that the plan, if implemented, will achieve the regional greenhouse reduction targets for 2035, a requirement of SB 375. In advance of the next plan update, SCAG's target will be updated by CARB. The target update process will consider statutory, technological, and policy factors that have changed since the last target setting process.





The presentation and discussion at the EAC retreat focused on how the development pattern has changed across Southern California since the adoption of SB 375, as well as, how transportation investments have shifted to support cleaner mobility. EAC members also reflected on the opportunities and challenges the region has faced, including a lag in housing production, and discussed factors to be considered as part of the target update process and/or legislative reform. Members also discussed the role of technology and the need to reexamine the framework for SB 375 as gas-powered vehicles are replaced by a zero-emission fleet. SCAG staff anticipates inviting the California Air Resources Board to speak to changes in the policy environment at an RC meeting this year and will continue to facilitate conversations on SCAG's role in addressing climate change at the Policy Committees.

Evaluation of the 2024 Regional Conference and General Assembly

Javiera Cartagena, Chief Government and Public Affairs Officer, presented a summary on the 2024 Regional Conference and General Assembly Post-Event Report, highlighting metrics used in evaluating the event. Notably, the 2024 event exceeded the past year's events in registration, attendance and sponsorship revenue. Overall, a majority (56%) of attendees reported high satisfaction with the event, indicating that it met or exceeded their expectations. In post-event surveys, attendees also noted that event content and networking were their top reasons for attending.

In response to the presentation, Committee members discussed their feedback on the event as well as thoughts for how to improve it in future years. Some points of discussion included ideas for creating more focused networking opportunities during portions of the event, feedback on the use of media during the event and opportunities throughout the program to highlight specific issues in each county. Additionally, the committee expressed interest in receiving updates on event planning throughout the year and the potential for integrating Regional Conference and General Assembly programming with other workshops and panels throughout the year.

2024-2025 Presidential Priorities and Policy Committee Outlooks for the Upcoming Year

To facilitate a conversation on policy priorities and agenda setting for the upcoming year, SCAG staff shared the attached 2023-2024 Accomplishments (Attachment 1) and a preliminary set of priorities for 2024-2025 that were developed with feedback from President Hagman. During the retreat, President Hagman reiterated his interest in SCAG playing a leadership role on emerging technologies across all policy areas, including through more dialogue and information sharing during the Regional Council meetings. The EAC discussed and confirmed direction to staff to focus on emerging technologies as a key theme for agenda development, in addition to carrying forward discussions on transit recovery, goods movement and clean transportation technologies. The EAC also provided input on the remaining preliminary priorities as reflected in the updated Regional



Council Outlook (Attachment 2). The EAC also discussed the structure of the Regional Council meeting and members' interest in reserving time to discuss cross-cutting issues by relying more upon the Policy Committees to take a larger role in addressing the business issues within their purview. This approach would minimize duplicative presentations at the Policy Committees and Regional Council, and instead, Policy Committee Chairs would be asked to briefly report out to the Regional Council on the recommended action items from their respective Policy Committees. Staff also shared with the EAC preliminary outlooks for each of the Policy Committees and noted that individual meetings would be set up with the Chairs and Vice Chairs prior to the September meetings to finalize the Policy Committee Outlooks.

Revised Regional Council Meeting schedule and Resumption of In-Person Regional Council Meetings

President Hagman and the Committee members engaged in discussions regarding the schedule of the EAC, Policy Committees and Regional Council meetings. Additionally, President Hagman expressed interest in having members return to in-person for all Regional Council meetings, while allowing for both in-person and remote participation options for the Policy Committees.

Beginning in September, and at least through the end of the calendar year, meetings of the Regional Council and EAC will be conducted in-person with no remote participation option. The Policy Committee meetings will continue to be conducted in hybrid format. Also, to more effectively facilitate these in-person meetings, the EAC will return to the first Thursday of the month. The revised schedule for regular EAC, Policy Committees and the Regional Council is as follows:

2023-2024 EAC Work Plan Accomplishments

Priority Area 1: Regional Policy Development—Regional Plan Update

2023-2024 Accomplishments:

- 1. Adopted an agency-wide SCAG Strategic Plan, grounded in extensive external and internal stakeholder participation, that identifies clear priorities, objectives and key results for near and medium-term coordinated actions.
- 2. Adopted Connect SoCal 2024 to direct resilient transportation investments and guide the region's jurisdictions towards an equitable and sustainable regional development vision.
- 3. Engaged elected leaders and community partners in the challenges facing Southern California by seeing firsthand examples of solutions through site visits, mobile workshops and training, including hosted tours of the new CA Air Resources Board (CARB) facility in Riverside, the ESRI campus in Redlands and Port Hueneme in Ventura County.
- 4. Brought together public and private sector leaders to identify challenges, share solutions and advocate for policies that support transit recovery, goods movement, and a smooth transition to clean transportation technologies, all key Presidential Priorities.

Priority Area #2: Leadership in Resource Deployment—Connect SoCal Implementation

2023-2024 Accomplishments:

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Honorable Curt Hagman called the meeting to order at 3:01 p.m. President Hagman led the Pledge of Allegiance.

President Hagman opened the Public Comment Period and outlined instructions for public comments. Seeing no public comment speakers, President Hagman closed the Public Comment Period.

REVIEW AND PRIORITIZE AGENDA ITEMS

1. Approval of Amendment No. 3 to Executive Director's Employment Agreement

There were no public comments for Item 1.

Board Counsel Ruben Duran provided members a brief report on Item 1. He explained that as directed by the EAC at one its recent meetings, pursuant to a successful performance evaluation of the Executive Director they had before them a proposed amendment number 3 to his employment agreement. He stated the only item that proposed amendment affected was [the Executive Director's] annual base salary as directed by the EAC, and negotiated with Mr. Ajise, and himself on





behalf of the EAC. Board Counsel stated the amendment reflected a 3% merit increase in his salary. Lastly, he stated there were no other proposed adjustments to any provision of [the Executive Director's] agreement.

2. Approve SCAG Participation in the 2024 Paris Olympic Games Observation Program and Study Tour

There were no public comments for Item 2.

Darin Chidsey, Chief Operating Officer, provided a brief report for Item 2. He stated the SCAG region was set to host the Olympics in four years, and that SCAG had been participating in the Games Mobility Executive Group for about a year now. He shared this group was charged to create the transportation plans for the Olympic games. He stated there were different roles and responsibilities to each of the members, however collectively, the group was charged with a really large task. He stated that members of the group were going to be traveling to Paris during the summer to participate in what is called the Observer Program. He stated they were seeking approval because SCAG's Bylaws and Policy Manual indicates that any international travel must be approved by the Regional Council, and they were seeking to send two staff members to participate in that Observer Program. However, he shared they knew there were other opportunities that might arise over the course of the summer, and they were also asking for approval for as many as two additional staff members and two Regional Council members to participate in events that have not been specified yet. Lastly, he stated that because it took the Regional Council's approval to approve international travel, and they were unsure about what other opportunities might arise over the next 6 to 8 weeks, and the Regional Council was dark in July, they were asking that specifically for Olympic travel, they delegate that authority to the Executive Director, should any unique opportunities arise that would be in SCAG's best interest to participate in, as they prepare for the 2028 Olympics.



Regional Council member Wendy Bucknum, Mission Viejo, District 13 expressed her support and excitement in relation to this item. She also asked for clarification if they wanted to put a [monetary] cap on this item. She stated it did not have a cap as far as additional monies. She stated she was supportive of that, so that staff had the authority.

President Hagman stated they currently had \$45,000 and asked Mr. Chidsey to confirm.

Mr. Chidsey stated they were correct, that it was for actual expenses up to \$45,000. He stated that if there were to be additional travel it would likely be above that and it would be hard to assess. He stated he understood if the committee was more comfortable about putting a cap on it as well. He offered to report back.

A MOTION was made (Solache) the Executive Administration Committee (EAC) recommend that the Regional Council approve: 1) Participation of up to two Regional Council members, in accordance with Article VIII, Section F of the Regional Council Policy Manual, and up to four SCAG staff in accordance with the SCAG Employee Travel Policy, in the 2024 Paris Olympic Games Observation Program and Study Tour in the early part of August, and after the Games to meet with the Paris delegation on lessons learned in preparation for the LA28 Olympic Games; 2) Delegation of authority to the Executive Director to approve international travel, specific to the 2024 Paris Olympic Games, for any needed additional SCAG international travel related to the 2024 Paris Olympic Games; and 3) Expenditure of approximately \$45,000 to cover travel expenses which will be allocated from SCAG's General Fund, Project Number 800-0160.01, and the expenditure of additional funds to cover travel expenses for any additional international travel authorized by the Executive Director. CFO REPORT

Cindy Giraldo, Chief Financial Officer, thanked the committee for their support the previous month for the fiscal year 2025 budget and overall work program. She stated that subsequent to their approval, they submitted the overall work program to Caltrans and was happy to report they received their approval on May 29. She reported that similar to this time last year, staff was busy completing the awards for the Go Human call for projects. She stated this call would award \$461,000 across 15 projects throughout the region. She stated this would bring the total number of active and ongoing pass-through projects to just over 100, funded through 24 different special





grants. She stated that if they retained full REAP funding, they could anticipate approximately another 50 or more projects to add to that count. She reported SCAG's role as a pass-through agency had grown over the past few years. She stated that to provide some perspective in 2020, SCAG's highest number to date had been 16 active awarded projects, so this really showed their dedication to seeking out funding for the region. Furthermore, she reported SCAG's fiscal year 2025 membership invoices would be going out in the next couple of weeks, and they certainly appreciated their support in expediting or routing those for payment.

PRESIDENT'S REPORT

President Hagman provided an update on SCAGs Washington D.C. Advocacy Trip. He shared a few of the members traveled to Washington D.C. to advocate for federal legislative priorities to support planning needs for the upcoming Olympic games, as well as funding for programs to support housing production, complete streets and broadband efforts. He stated they were happy to hear from Senator Alex Padilla and Speaker Emerita Nancy Pelosi at their annual California Congressional Transportation Reception, which they co-hosted with their bay area counterpart, the Metropolitan Transportation Commission. He stated they also met with several representatives, including friends of SCAG, Congresswoman Norma Torres and Congressman Pete Aguilar. Furthermore, he reported last month, WTS International awarded this year's Honorable Ray LaHood Award to SCAG Executive Director Kome Ajise. He reported Mr. Ajise received the WTS-Los Angeles version of this award last fall, nominating him for the international award alongside 1,200 transportation leaders from all over the United States. He congratulated Mr. Ajise for this prestigious recognition. President Hagman also reported that he and SCAG Deputy Director of Planning Annie Nam participated in the Inland Empire Economic Partnership's Logistics and E-Commerce Summit. He stated Ms. Nam presented a white paper on the state of goods movement in the region and he spoke on a panel of experts discussing the issue, covering details of data in the trucking industry, the role of technology in improving goods movement and how SCAG can play a critical role supporting collaboration in this space. He reported the EAC and the Policy Committees would be dark in July in observance of Independence Day. He stated the next regular meeting of the EAC was scheduled for Wednesday, July 31, 2024, at 3 p.m. Lastly, he reported they would kick off the year with the EAC retreat on June 27-28 in San Bernardino County.

EXECUTIVE DIRECTOR'S REPORT

Kome Ajise, Executive Director, provided an update on REAP. He shared with members that after tireless legislative advocacy over the past few months, they received encouraging news. He reported the California State Assembly and State Senate announced a Joint Legislative Budget Plan, which proposed to restore significant funding for several programs proposed to be cut under Governor Newsom's January Budget proposal and May Revision. He stated that the Joint Legislative Budget Plan would restore \$250 million to the Regional Early Action Planning program (REAP 2.0),



of the originally proposed \$300 million cut and reject proposed cuts to the Active Transportation Program. He stated both programs provided important resources for implementing Connect SoCal 2024 and have been the focus of SCAG's recent advocacy. He stated they appreciated all of them and the many partners who worked alongside SCAG to highlight the importance of the projects made possible by these funding sources. He stated that while this news was encouraging, there were still several steps to negotiate a final budget and SCAG would continue focused advocacy throughout this process. He explained that if the budget was approved, SCAG staff hoped to move forward with significant REAP sub-allocations and would continue engagement to "restart" the program once the budget was finalized. He shared that given a lot could happen between then and June 15, SCAG staff were preparing for all scenarios and encouraging partners to continue advocacy. Mr. Ajise also provided an update on AB 2485 by Assemblymember Juan Carrillo. He stated this was SCAG's sponsored bill that sought to increase transparency measures concerning the RHNA determination process. He stated the bill passed in the Assembly Committee on Housing and Community Development on April 17, then moved through the Assembly Local Government and Appropriations Committees, before going back to the Assembly floor on May 22, where it was passed unanimously. He shared it was now headed to the Senate where it would likely be assigned to the Senate Housing Committee. Mr. Ajise also provided the members with a General Assembly Recap. He thanked all the members that attended the 2024 Regional Conference and General Assembly in Palm Desert. He shared they had more than 800 attendees gathered for the event, along with esteemed speakers, panelists, partners and sponsors, who contributed to productive discussions on the pillars of Connect SoCal 2024: mobility, housing and communities, the environment and the economy.

ADJOURNMENT

There being no further business, President Hagman adjourned the Meeting of the Executive Administration Committee at 3:25 p.m.

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Honorable Curt Hagman called the meeting to order at 12:16 p.m. and lead the Pledge of Allegiance.

PUBLIC COMMENT PERIOD

President Hagman opened the Public Comment Period.

The Clerk acknowledged there no written public comments for items not listed on the agenda.

Seeing no public comment speakers, President Hagman closed the Public Comment Period.

REVIEW AND PRIORITIZE AGENDA ITEMS

There was no prioritization of agenda items.

INFORMATION/DISCUSSION ITEMS

1. Welcome, Opening Remarks, Introductions, Agenda Review and Expectations

There were no public comments speakers for Item No. 1.



President Hagman provided opening remarks and had EAC members and staff introduce themselves.

2. SCAG 101: Overview of Organization

There were no public comments speakers for Item No. 2.

Darin Chidsey, Chief Operating Officer provided an overview of the organization which included a review of the SCAG region, vision, mission, core values, primary roles and responsibilities, strategic plan implementation, Executive Team Organizational Chart, agency budget and overall work program, five-year budget history, five-year staffing history, and funding horizon.

The EAC members and staff briefly engaged in discussions about the five-year budget, staffing levels, future projections, and funding sources. Executive Director Ajise also provided background information on STBG/CMAQ funding and SCAG's involvement moving forward.

3. Board Employment Classification Update

There were no public comments speakers for Item No. 3.

Jeffery Elder, Chief Counsel, provided an update on the classification of board members as independent contractors versus employees. He explained that an IRS finding regarding Metrolink, which required their board members to transition from 1099 independent contractors to W-2 employees, had prompted SCAG to reassess its own practices. He described the steps taken by SCAG to assess the situation and his presentation included information on the first legal opinion they requested from Liebert Cassidy Whitmore (LCW), outside counsel for employment and human resources, which came back indicating that the Board was likely employees. He noted that SCAG's legal department found the opinion to be rather conservative on the control and direction aspects since SCAG was unique in the way it was set up, so they asked Best Best & Krieger (BBK) for a second opinion. He reported that Isabel Safie at BBK directed them to Section 530 of the Revenue Act of 1978, a safe harbor provision which allows for an entity to continue to 1099 their independent contractors if they met certain criteria: 1) consistently treated the board as an independent contractor; 2) consistently reported compensation on form 1099; and 3) reasonable basis exists for treating board as non-employees, all of which SCAG met. He further explained that there was another factor that could be considered, and they looked at whether they could demonstrate a long-standing recognized practice at a significant segment of the industry. As a result, he indicated that they reached out to their fellow MPO's, 18 in the state, and got responses from almost all of them. He noted that based on the survey results, they concluded that they would be able to meet Section 530 Safe Harbor provision. He also reported that they asked LCW to look at





this considering these new findings and they had come back indicating that they agreed that Section 530 would likely apply in SCAG's case. To add to this, he also noted that AMBAG let them know that back in 2013 they received notification from the IRS that their board was considered independent contractors and not employees, which was a good precedent to demonstrate that SCAG had a reasonable reason to continue to treat their members as independent contractors under Section 530. Lastly, based on the information presented, staff recommended continuing to treat SCAG's board members as independent contractors, which the EAC agreed with.

President Hagman thanked Board Counsel Duran and staff for going back and researching the issue to come up with a recommendation. President Hagman also noted the liabilities it could bring to SCAG if they needed to start managing breaks, vacation, and workers comp, all expenses that SCAG or other public entities would have to take on.

4. Policy Briefs and Emerging Issues

There were no public comments speakers for Item No. 4.

Executive Director Ajise shared that the following presentation would focus on transportation finance, housing, and Sustainable Communities Strategy.

Transportation Finance

Anni Nam, Deputy Director of Transportation Planning, provided a presentation on the state's effort to prepare a transportation needs assessment for the next 10 years to better understand costs associated with operating, maintaining, and providing for the future growth of the transportation system, including climate change impacts in response to SB 1121. She also noted that the state faces a \$200-300 billion funding shortfall for transportation over the next 10 years and that concerns have been raised about statewide consistency in defining needs and assumptions regarding responsibilities for achieving ambitious statewide goals. She noted that California Transportation Commission staff held two workshops and the focus was on a core set of principles addressing revenue needs, as well as some new funding model scenarios for the state. She also noted that Connect SoCal 2024 included forecasts on the significant revenue decline from Zero-Emission Vehicles (ZEV) adoption and briefly touched upon the guiding principles to identify new revenue sources. She emphasized the importance of sustainable funding sources and the need to address the decline in gas tax revenue to ensure the state's transportation infrastructure can meet future needs. She also touched upon the next steps to advance the revenue conversation and highlighted the importance of being engaged in state process or pilot programs, support for express lanes, the need to elevate equity conversations, and support for local road user charge research and pilots.





The EAC Committee and staff briefly engaged in discussions on next steps to advance the revenue conversation. There was also an emphasis on the importance of continuing advocacy efforts for the region's express lane system. Additionally, discussions focused on how transportation funding is becoming increasingly inequitable and how opportunities to stabilize transportation revenues via a road charge program, can potentially serve to mitigate some of these existing equity challenges.

Housing

Elizabeth Carvajal, Deputy Director of Land Use, provided an overview on the state of housing, housing production, Regional Housing Needs Assessment (RHNA) housing element compliance, SCAG funding, and technical assistance programs. She briefly provided a historical perspective on building permits issued in the SCAG region for both single family and multi-family units from 1990 to 2023. She also noted in her presentation that as of June 12, 2024, 144 jurisdictions were compliant with their housing elements. She included information on the noncompliant cities and indicated that most of the jurisdictions in this category had a population under 100,000, many having a median household income of \$50,000 or less. She reminded the Committee that SCAG received \$47 million under REAP 1.0, and they were able to allocate funding across the region to over 100 projects and 53 awardees to execute a series of activities that support housing production across the region. Her presentation included information on the REAP 1.0 outcomes and noted that jurisdictions had adopted programs that increased fair housing, developed pre-approved plans, provided technical assistance around housing element work to 121 jurisdictions, and conducted stakeholder engagement which included over 1,500 meetings and engagement by residents, stakeholders, and elected officials. Her presentation also included a brief overview on the REAP 2.0 program and the various efforts that will support housing production through policy, financing and infrastructure planning, and implementation. Lastly, she provided and overview on the State's California's Housing Future 2040: The Next RHNA Report. She noted that AB 101 tasked HCD with preparing a report that outlined how to improve the RHNA process. The report was released in April 2024 and is organized by method of implementation as well as by three topic areas: regional determination process, the COG-led processes, such as methodology and appeals, and consistency with the RTP/SCS and growth forecasts. She shared that staff was in the process of reviewing the report and would provide to Community, Economy, and Human Development (CEHD) Committee a summary of the report and how it does or does not respond to SCAG's comment letter.

Javiera Cartagena, Chief Government and Public Affairs Officer, reported that earlier in the year the Governor had cut REAP 2.0 funding from his proposed budget. Her presentation included an update of the advocacy efforts to save the program and request for funding to be reinstated. Efforts consisted of a letter writing campaign from the cities and counties in the SCAG region, getting support from the GLUE Council to show they had support from the private sector, building coalition letters from the County Transportation Commissions and MPO's, and creating material to showcase the REAP 2.0 program. She also highlighted the Sacramento Summit and Strike teams that met with legislative offices, legislators, and assembly members to advocate for the program. Lastly, she





briefly touched upon the different types of legislation that was coming out as a result of the RHNA report such as: AB 3093 (Ward) that would add two new income categories to the RHNA program; SB 7 (Blakespear) that would require outreach to special needs households, shorten timeframe for appeals, eliminate sub-regional delegation, and shorten HCD review of methodology; AB 1335 (Zbur) that would require the RTP/SCS to assume the development of the full RHNA determination within the first eight years of the RTP/SCS planning cycle; and AB 2485 (Carrillo) which would increase transparency of the RHNA determination process.

The Committee and staff discussed efforts to address the housing crisis through advocacy, highlighting the importance of REAP in the state budget, and streamlining the affordable housing development process. They addressed the issue of ADU's and building permit process. Members emphasized the need to increase building permits to meet population needs and for incentive models to encourage builders to prioritize affordable units. It was also suggested studying obstacles to recovery and advocating for legislation.

Sustainable Communities Strategy (SCS)

Sarah Jepson, Chief Planning Officer, provided an overview of State policies aimed at reducing greenhouse gas emissions and the progress and challenges the SCAG region has faced in meeting ambitious state goals. She briefly addressed the evolution of SCAG's SCS and noted that the goal was to focus on aligning land use planning with transportation investments to achieve greenhouse gas emissions reduction targets. Also, despite the California Air Resources Board (CARB) SCS report indicating that California was not on track to meet greenhouse gas reductions, she noted that the region had made some advancements in increasing the diversity of house types by adding 500,000 more households and one million more jobs near transit since the adoption of SCAG's first RTP/SCS in 2012. The presentation also focused on how the development pattern had changed across Southern California since the adoption of SB 375, as well as, how transportation investments had shifted to support cleaner mobility. She also highlighted that the region had increased investment in local planning, but cities lacked support and capacity for implementation. She briefly addressed the next steps in relation to SB 375 and discussed the lack of support for implementation, the increasing conflict between federal and state objectives for the regional plan, and technology advancements in relation to E-VMT and GHG. She also reported that it would be good to see reform in certain areas as they work on implementation of the plan.

EAC members reflected on the opportunities and challenges the region has faced, including a lag in housing production, and discussed factors to be considered as part of the target update process and/or legislative reform. Members also discussed the role of technology and the need to reexamine the framework for SB 375 as gas-powered vehicles are replaced by a zero-emission fleet. The need for more resources to address transit safety issues was also addressed. The conversation also centered around alternative transportation solutions and funding strategies.

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Honorable Hagman called the meeting to order at 8:08 a.m. and lead the Pledge of Allegiance.

INFORMATION/DISCUSSION ITEMS

1. Recap on Day 1

There were no public comments speakers for Item No. 1.

President Hagman indicated they had great conversations the day before and thanked staff for putting a lot of thought into this. He also acknowledged the work that the Policy Committee Chairs would be doing to get business done as they focused on the year ahead.

2. 2024 Regional Conference and General Assembly Evaluation

There were no public comments speakers for Item No. 2.

Javiera Cartagena, Chief Government and Public Affairs Officer, provided a report on the 2024 Regional Conference and General Assembly and highlighted metrics used in evaluating the event. The 2024 event exceeded the past year's events in registration, attendance and sponsorship revenue. She also indicated that many attendees reported high satisfaction with the event, indicating that it met or exceeded their expectations.

Committee members provided feedback on the event as well as thoughts for how to improve it in future years. Some points of discussion included ideas for creating more focused networking opportunities during portions of the event, feedback on the use of media during the event and opportunities throughout the program to highlight specific issues in each county. Additionally, the committee expressed interest in receiving updates on event planning throughout the year and the potential for integrating Regional Conference and General Assembly programming with other workshops and panels throughout the year.



3. Presidential Priorities: Regional Council and Policy Committee Outlooks

There were no public comments speakers for Item No. 3.

President Hagman and the Committee members engaged in discussions regarding the meeting schedule of the EAC, Policy Committees and Regional Council. Additionally, President Hagman expressed interest in having members return to in-person for all Regional Council meetings, while allowing for both in-person and remote participation options for the Policy Committees and other committees of SCAG. He also reiterated his interest in SCAG playing a leadership role on emerging technologies across all policy areas, including through more dialogue and information sharing during the Regional Council meetings.

The EAC discussed the structure of the Regional Council meeting and members' interest in reserving time to discuss cross-cutting issues by relying more upon the Policy Committees to take a larger role in addressing the business issues within their purview. This approach would minimize duplicative presentations at the Policy Committees and Regional Council, and instead, Policy Committee Chairs would be asked to briefly report out to the Regional Council on the recommended action items from their respective Policy Committees.

Ms. Jepson also acknowledged the accomplishments from the previous year and shared a preliminary set of priorities for 2024-2025 that were developed with feedback from President Hagman. She noted that they would continue progress on the Presidential Priorities focusing Regional Council leadership on goods movement, transit recovery, and clean transportation technology with an emphasis on optimizing emerging technologies. She also shared with the EAC preliminary outlooks for each of the Policy Committees and noted that individual meetings would be set up with the Chairs and Vice Chairs prior to the September meetings to finalize the Policy Committee Outlooks.

Ms. Cartagena briefly discussed the ways members could get involved, whether through legislative advocacy, participating in the mobile workshops or attending project milestone events.

4. Wrap up

Kome Ajise, Executive Director, provided a brief recap of the discussions from the prior day regarding transportation finance, housing, and the SCS revamp. He also expressed appreciation for the member feedback on the General Assembly and how they could make the 60th Anniversary General Assembly a great event next year. He also highlighted the conversation they had on the priorities, the Policy Committee Outlooks, and the meeting schedule for the Regional Council and Policy Committees.

RECOMMENDED ACTION:

That the Executive Administration Committee, on behalf of the Regional Council, approve: 1) travel and participation of one (1) Regional Council Board Member, in accordance with Article VIII, Section F of the Regional Council Policy Manual, and up to two (2) staff members, in accordance with the SCAG Employee Travel Policy, in the Los Angeles Clean Tech Incubator (LACI) Transportation Electrification Partnership (TEP) International Study Trip, September 1-10, 2024; and 2) the estimated expenditure of approximately \$25,500 to cover participant fees and other travel-related costs which will be allocated from SCAG's FY24-25 General Fund Budget.

STRATEGIC PRIORITIES:

The delegation seeks to expose California public policy leaders to key policies and best practices driving transportation electrification in regions with high Electric Vehicle (EV) adoption and extensive public transit use. Per SCAG's Regional Council Policy Manual and the Employee Travel Policy, foreign travel requires the Regional Council's approval.

BACKGROUND:

SCAG has been invited by LACI to participate in a delegation of senior public and private sector leaders who are shaping the future of California's transportation electrification on a professional study trip to London (England), Oslo (Norway), and Munich (Germany). The event is a 10-day trip where delegates will have the opportunity to meet with European officials and industry leaders to





learn about innovative policy, technology, and business models in effect in these leading cities, and to be exposed to new ideas that could serve as the basis for innovation in Southern California. Each of the three cities to be visited has committed to bold transportation electrification, climate, and air quality goals, and is leading on a variety of policy innovations. The delegation is focused on three key areas: passenger vehicle electrification, multi-modal transit expansion, and electrification of goods movements.

Delegates will meet with officials responsible for implementing:

- Deployment of EV charging infrastructure
- Land use and permitting policies to support EVSE deployment
- Zero emission zones and/or congestion pricing
- Electrification of public transit (buses and rail)
- Electrification of trucking to serve ports

Identifying strategies to accelerate clean transportation and mitigating the negative impact of the transportation system on regional air quality have been long standing priorities for SCAG. With the advancement and proliferation of clean transportation technologies, coupled with the urgency of addressing climate change, the vision of a zero-emission transportation system is a core component of SCAG's 2024 Connect SoCal, Regional Transportation/Sustainable Communities Strategies (RTP/SCS). Participation in LACI's TEP International Study Trip would further SCAG's efforts to create and maintain partnerships with other nations to exchange valuable information that support these efforts. SCAG will also have the opportunity to network with influential California State Officials and policymakers who are part of the delegation. The trip will be co-hosted by Liane Randolph, Chair of the California Air Resources Board (CARB).

LACI is a nonprofit organization established by the City of Los Angeles and seeks to create an inclusive green economy by: unlocking innovation through working with startups to accelerate the commercialization of clean technologies, transforming markets through partnerships with policymakers, innovators and market leaders in transportation, energy and sustainable cities; and enhancing communities through workforce development, pilots and other programs. Founded as an economic development initiative by the City of Los Angeles and its Department of Water and Power (LADWP), LACI is recognized as one of the most innovative business incubators in the world by UBI.

Leveraging CAV to Improve Fuel Economy, Wednesday 11:00 to 12:30, description:

Extensive research has been performed to demonstrate that CAV technology can improve the safety of driving. Another benefit of the technology is that it can be leveraged to improve fuel economy and reduce emissions if the technology is tuned to both address safety and more efficient operation of the vehicle. EXECUTIVE SUMMARY:

At its June 18, 2024, meeting, the Legislative/Communications and Membership Committee (LCMC) approved up to \$35,772 to renew memberships with 1) the American Public Transportation Association (\$5,772) and 2) the Association of Metropolitan Planning Organizations (\$30,000).

BACKGROUND:

Item 1: American Public Transit Association (APTA)

Type: Membership **Amount:** \$5,772

The American Public Transportation Association (APTA) is a leading force in advancing public transportation. APTA members include transit systems, government agencies, manufacturers, suppliers, consulting firms, contractors, and other business partners. To strengthen and improve public transportation, APTA serves and leads its diverse membership through advocacy, innovation, and information sharing. An annual membership provides SCAG access to the highest-quality tools, resources, and programs, including advocacy efforts, networking and partnership opportunities, the latest industry research and data, and professional development. These benefits are valuable considering recent and continued work in Congress on providing aid to transit agencies in light of the Coronavirus Disease 2019 (COVID-19) pandemic and its aftermath on transit systems, as well as transportation reauthorization legislation and spending bills.





SCAG is seeking to renew its membership with APTA in the "Category D – Governmental Agencies" level of \$5,772. This is the same cost as last year's membership with APTA and is consistent across non-operating state departments of transportation, metropolitan planning organizations (MPOs), and governmental agencies, including agencies of local or regional levels of government responsible for the planning and/or development of public transit system.

Item 2: Association of Metropolitan Planning Organizations

Type: Membership Amount: \$30,000

The Association of Metropolitan Planning Organizations (AMPO) is a nonprofit membership organization established in 1994 to serve the needs and interests of metropolitan planning organizations (MPOs) nationwide. AMPO offers member MPOs technical assistance and training, frequent updates on federal policy, research findings and analysis, and conferences, workshops, and forums for collaboration and peer sharing. SCAG became a member of AMPO in November 2023 and paid \$15,000 in dues, which is half of the usual cost since our membership started almost halfway into the fiscal year. SCAG is now renewing its membership for the next full fiscal year at the full cost of \$30,000.

AMPO's annual national conference provides a robust program covering current issues, including the future of transportation, data collection, legislative issues, and roundtable discussions relating to MPOs from all regions. Additionally, AMPO members can join the member-run Technical Committee. This committee works to define planning practices that develop key transportation proposals via various technical support, including active transportation initiatives, emerging technologies, GIS and data visualization, and more.

FY 2024-2025 dues are calculated by multiplying the 2010 urbanized area (UZA) population by .006 for non-TMA (Transportation Management Area) MPOs or .007 for TMA MPOs (UZA Population \times .006 or .007), which amounts to \$30,000 for SCAG. Membership includes the following:

- 7 Online Discussion Forums focused on Active Transportation, Data, GIS and data Visualization, Core Products, Environment and resiliency, Socioeconomic Forecasting, and Emerging Technologies.
- Invitation to AMPO's annual conference with hundreds of other planners nationwide
- Access to the Spring Planning Tools & Training Symposium, which is a biennial event that provides a technical deep dive to advance the practices of MPOs.
- Access to archived and current policy materials drafted by the AMPO Policy Committee on the future metropolitan vision.
- Legislative tracking and regular updates on all Congressional items relating to transportation systems and metropolitan planning.





• The opportunity to hold a seat (MPO members) on the AMPO Policy Committee. This Committee is the liaison between the AMPO Board/Staff and the MPO Community.

PRIOR COMMITTEE ACTION:

Staff presented the agenda item for up to \$35,772 for memberships with 1) the American Public Transportation Association (\$5,772) and 2) the Association of Metropolitan Planning Organizations (\$30,000) to the LCMC at its meeting on June 18, 2024. The LCMC approved this item unanimously as part of the consent calendar.

FISCAL IMPACT:

\$35,772 for membership with APTA and AMPO is included in the approved FY 24-25 General Fund Budget.

SCAG staff notified 5,440 firms of the release of RFP 24-050 via the PlanetBids website and emailed the invitation to bid. A total of 33 firms downloaded the RFP. SCAG received one (1) proposal in response to the solicitation. After receiving only one (1) proposal, staff surveyed 33 firms that downloaded the RFP to determine why each did not submit a proposal. Only one (1) firm responded to staff's inquiry, which disclosed the main reason the firm did not respond to the published RFP was that they were inept to meet the requirements listed in the Scope of Work, thus determining they would not be a good fit for SCAG. Note staff advertised the RFP during the normal four (4) week period. Staff subsequently moved forward with reviewing the one (1) offer. Staff requested and received Caltrans authorization to proceed with evaluating the single offer

received. Staff believes that soliciting for a second time would not yield a different result and needed to maintain the project's schedule and, therefore, proceed to evaluate the one (1) offer.

Selection Process:

The Proposal Review Committee (PRC) reviewed the one (1) offer received and determined the firm possessed the skills and qualifications to perform the tasks listed in the project's scope of work.

This amendment increases the contract value from \$219,226 to \$291,596 (by \$72,370) and extends the contract term from June 30, 2024, to June 30, 2025.

This increase is due to necessary refinements for Task 2.2, SCAG's Digital Literacy Toolkit, and Task 3.3, Data Collecting and Mapping. Task 2.2 refinements will tailor the toolkit to institutions such as community-based organizations (CBOs), local governments, instructors, and faith-based organizations. STRATEGIC PRIORITIES:

This item supports the following Strategic Priority 5: Secure and optimize diverse funding sources to support regional priorities.

ACCOUNTING:

Membership Dues

As of June 30, 2024, 188 cities, six counties, seven commissions, and ten tribal governments have paid their FY24 membership dues. SCAG has collected \$2.46M out of the \$2.48M billed. This represents 99.30% of the membership assessment.

Investments & Interest Earnings

As required by SCAG's investment policy adopted by the Regional Council in July 2018, staff will provide a monthly report of investments and interest earnings. During FY 2022-23, SCAG transferred all funds invested in the Los Angeles County Investment Pool to the Local Agency Investment Fund (LAIF) account, except for any outstanding interest gains received in July 2023. The Los Angeles County Investment Pool account was closed in August 2023. As of June 30, 2024, SCAG has invested \$26.91 million in the LAIF account and has earned \$711,109.15 in interest income. The interest earnings are distributed quarterly, with an average interest rate of 4.30%. Additionally, SCAG has earned \$32.31 in interest from the Los Angeles County Investment Pool before closing that account in August 2023. Furthermore, SCAG has opened a Money Market Account to maximize interest income while monitoring the REAP's funding balance; interest earnings from this account are distributed monthly. As of June 30, 2024, SCAG has invested \$48.26 million in the Money Market Account and has earned \$540,891.21 in interest income.

<u>Incurred Cost Audit by Caltrans</u>

SCAG Finance has provided to Caltrans the requested records, information, and documentation. Auditors are currently working on procurement and in-kind match and are sending follow-up



questions/requests. Audit work is anticipated to wrap up within the next few weeks, and then a report on the audit results will be prepared by Caltrans for review and comment by SCAG.

BUDGET & GRANTS (B&G):

On July 30, 2024, SCAG submitted the FY 2023-24 (FY24) Overall Work Program (OWP) 4th Quarter Progress Report with preliminary expenditures to Caltrans. The 4th Quarter Progress Report with final expenditures and the FY24 OWP Final Work Products will be submitted to Caltrans by August 30, 2024.

Also, SCAG received conditional awards for the FY24-25 Sustainable Transportation Planning Grant Program — Strategic Partnerships, and staff are currently working on addressing the comments received from Caltrans. The grant award information is as follows:

- \$500,000 in grant for the project entitled, "Planning for Main Streets"
- \$500,000 in grant for the project entitled "Southern California Airport Passenger Surface Transportation Study."

CONTRACTS ADMINISTRATION

The Contracts Administration Department staff supports 11 active procurements and 182 active contracts. Staff is working with project managers to complete the close-out process for 43 contracts that ended on June 30, 2024. Staff executed three (3) contracts for more than \$25,000 but less than \$500,000 and five (5) contract amendments for more than \$5,000 but less than \$150,000 and 30% of the initial contract value. Additionally, staff processed 21 purchase orders to support ongoing business and enterprise operations as reported in the consent calendar agenda item "Purchase Orders, Contracts, and Amendments below Regional Council's Approval Threshold."
