CALL TO ORDER AND PLEDGE OF ALLEGIANCE

11. Clean Transportation Technology Program Update; PEV Study and Clean Transportation Technology Compendium

There were no public comments on Item 11.

Alison Linder, Senior Planner, provided an update on SCAG's Clean Transportation Technology Program and stated she would be sharing her time with consultant Taylor Briglio, Clean Mobility Manager at Wildan. She stated Mr. Briglio was the project manager of the team that did SCAG's Passenger Electric Vehicle Site Sustainability Study.

Policy Committee members sought clarification on some of the acronyms used in the presentation/study. Additionally, members asked about the criteria that was used in the Suitability Analysis, if rail was considered in their study and about the resources available to support the deployment of the infrastructure. SCAG staff, Mr. Briglio and Sarah Jepson, Chief Planning Officer addressed the various questions posed by the members.

Additionally, Vice Chair Plancarte provided an update on Connect SoCal Outreach, stating SCAG had concluded the in-person and virtual workshops for Connect SoCal that were held throughout the region in April and May 2023. He shared SCAG would present the highlights and findings from the Connect SoCal outreach to the Regional Council in July and would also ask the Executive/Administration Committee and Regional Council to approve an update to the Connect SoCal Policy Development Framework based on feedback received at the May Policy Committee meetings.

STAFF REPORT

Rachel Wagner, Government Affairs Officer, provided an update on the RHNA Reform Process and Schedule. She informed the members that the California Department of Housing and Community Development (HCD) was developing recommendations to reform the RHNA process, which would be provided in a report to the California State Legislature by December 31. Additionally, she stated that because this process involved stakeholder engagement, SCAG was seeking input from jurisdictions, stakeholders and the public on its draft RHNA reform recommendations through a brief public survey. In addition to the survey, she stated SCAG would hold a public listening session on June 22, with a second date still to be announced. She explained stakeholders could also submit comments at housing@scag.ca.gov which were due by June 30. Lastly, she stated SCAG would human Development Committee at a special meeting in August and to the Regional Council for final approval on September 7.
