INTERGOVERNMENTAL REVIEW BI-MONTHLY REPORT

Located in the City of Costa Mesa, County of Orange, California, the proposed project includes a mixed-use development of up to 1,057 multi-family dwelling units (anticipated to be rental units) 25,000 square feet (sf) of commercial creative office, 6,000 sf of specialty retail, and 1.5 acres of

open space on 15.23 acres.
