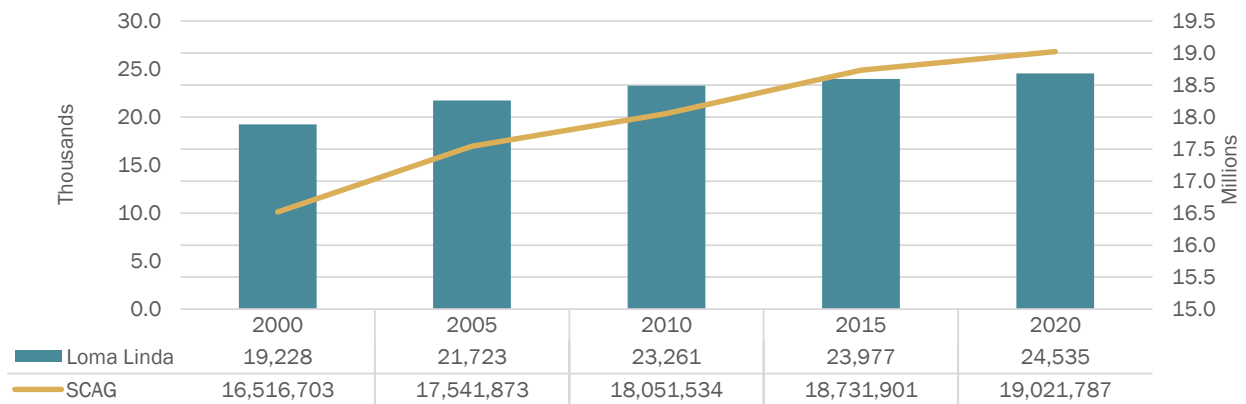
Pre-Certified Local Housing Data for Loma Linda

Developed by SCAG and pre-certified by the California Department of Housing and Community Development (HCD) for use in 6th cycle housing elements.

This report contains a wide range of jurisdiction-level data elements intended to provide an understanding housing need experienced in Loma Linda as a part of its 6th cycle housing element update. Data sources are noted below each table or figure.

I. POPULATION, EMPLOYMENT, AND HOUSEHOLDS

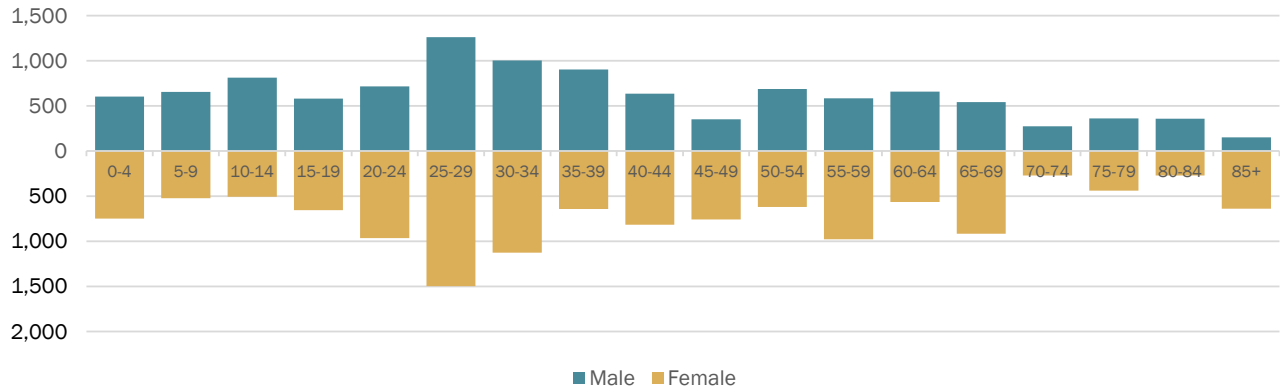
Population Trend, 2000-2020

Loma Linda has a 2020 total population of 24,535 including 735 living in group quarters according to the California Department of Finance. The chart above describes the population trend in Loma Linda from 2000 to 2020. Over this period Loma Linda had an annual growth rate of 1.2% compared to 0.7% for the region.

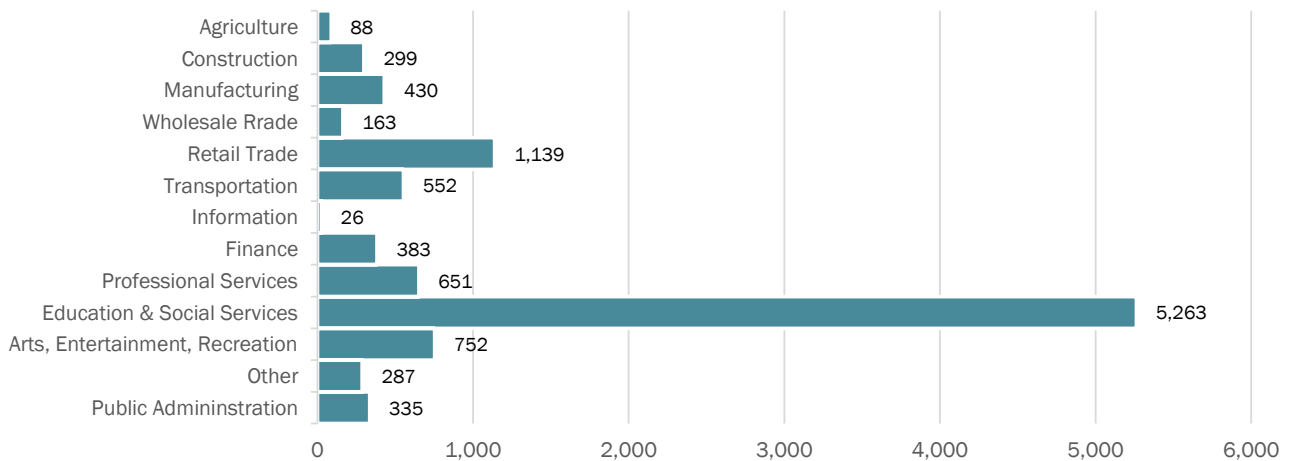
Current Population by Age and Sex

The population of Loma Linda is 46.2% male and 53.8% female. The share of the population of Loma Linda which is under 18 years of age is 19%, which is lower than the regional share of 23.4%. Loma Linda's seniors (65 and above) make up 17.5% of the population, which is higher than the regional share of 13%.

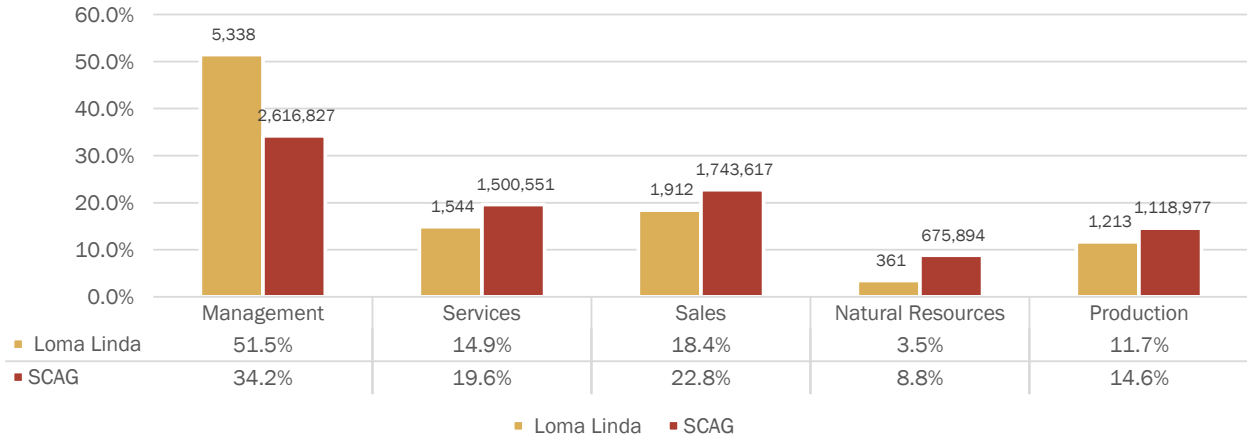
Employment by Industry

Loma Linda has 10,368 workers living within its borders who work across 13 major industrial sectors. The chart above provides detailed employment information. The most prevalent industry is Education & Social Services with 5,263 employees (50.8% of total) and the second most prevalent industry is Retail trade with 1,139 employees (11% of total).

In addition to understanding the industries in which the residents of Loma Linda work, it is also possible to analyze the types of jobs they hold. The most prevalent occupational category in Loma Linda is Management, in which 5,338 (51.5% of total) employees work. The second-most prevalent type of work is in Sales, which employs 1,912 (18.4% of total) in Loma Linda.

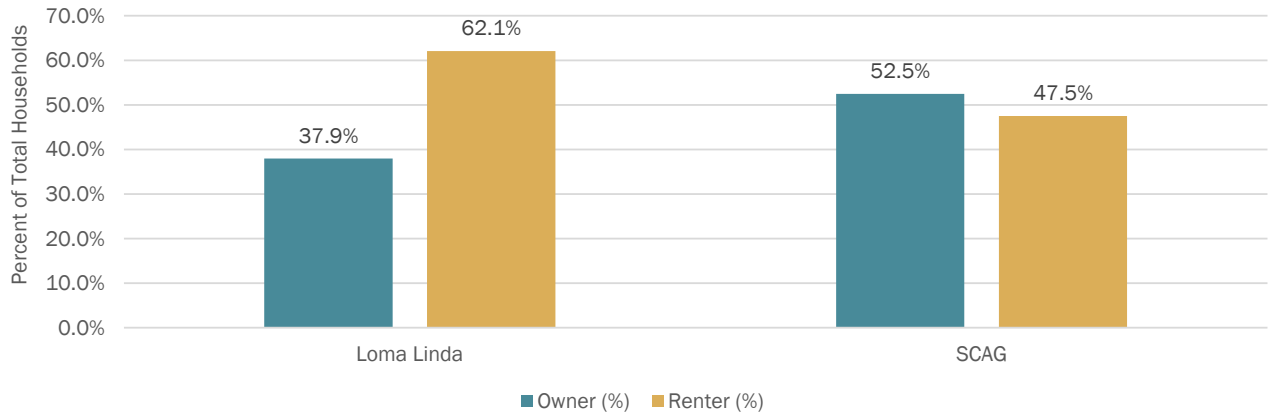

Statewide, farmworker housing is of unique concern and of unique importance. While only a small share of SCAG region jurisdictions have farmworkers living in them, they are essential to the region's economy and food supply.

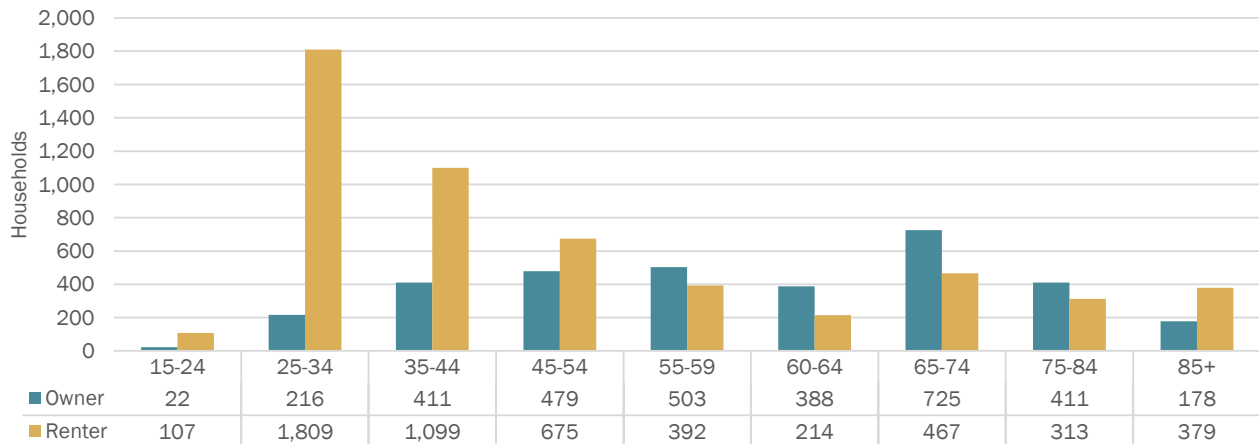
Housing Tenure

Housing security can depend heavily on housing tenure, i.e. whether homes are owned or rented. Loma Linda's housing stock consists of 8,788 total units, 3,333 of which are owner-occupied and 5,455 of which are renter-occupied. The share of renters in Loma Linda is higher than in the SCAG region overall.

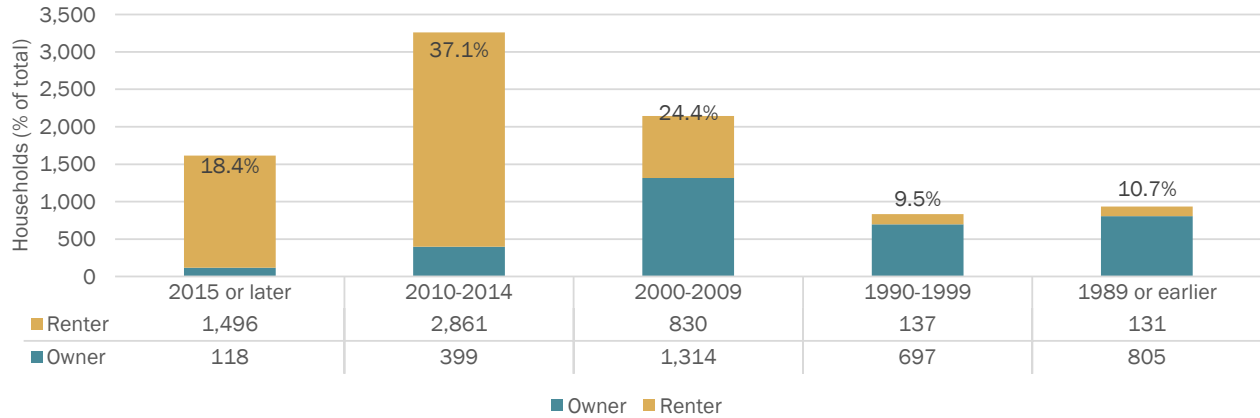
Housing Tenure By Age

In many places, housing tenure varies substantially based on the age of the householder. In Loma Linda, the age group where renters outnumber owners the most is 25-34 (by 78.7%). The age group where owners outnumber renters the most is 60-64 (by 28.9%).

Housing Tenure by Year Moved to Current Residence

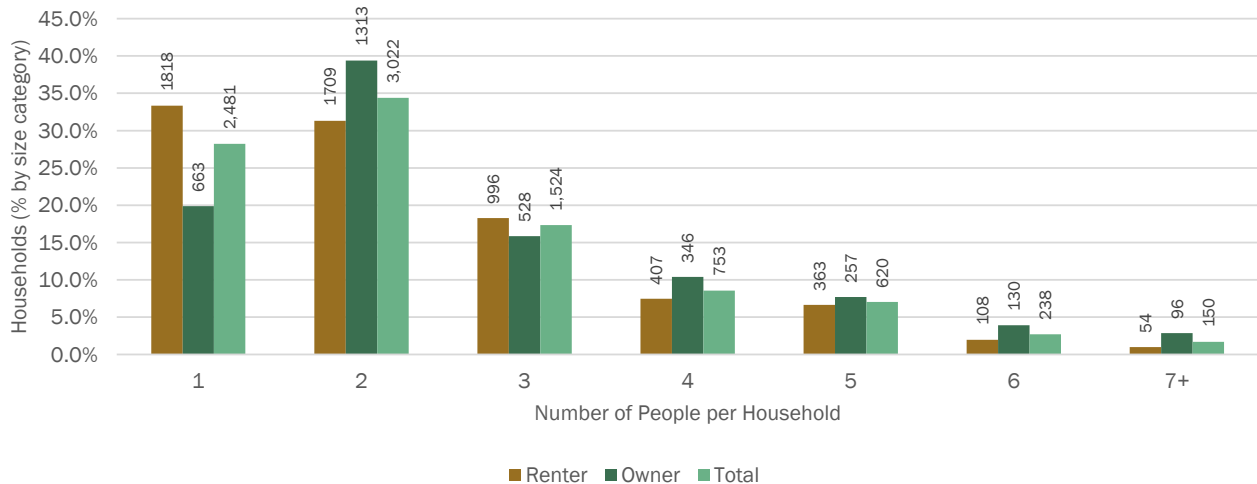

Across the SCAG region, the most common move-in period was 2010-2014 (31.9%) followed by 2000-2009 (26.1%). In Loma Linda, the period during which most people started living in their current residence was 2010-2014 (37.1%) followed by 2000-2009 (24.4%).

II. SPECIALIZED HOUSEHOLD NEEDS: LARGE FAMILIES, SENIORS, AND FEMALE-HEADED

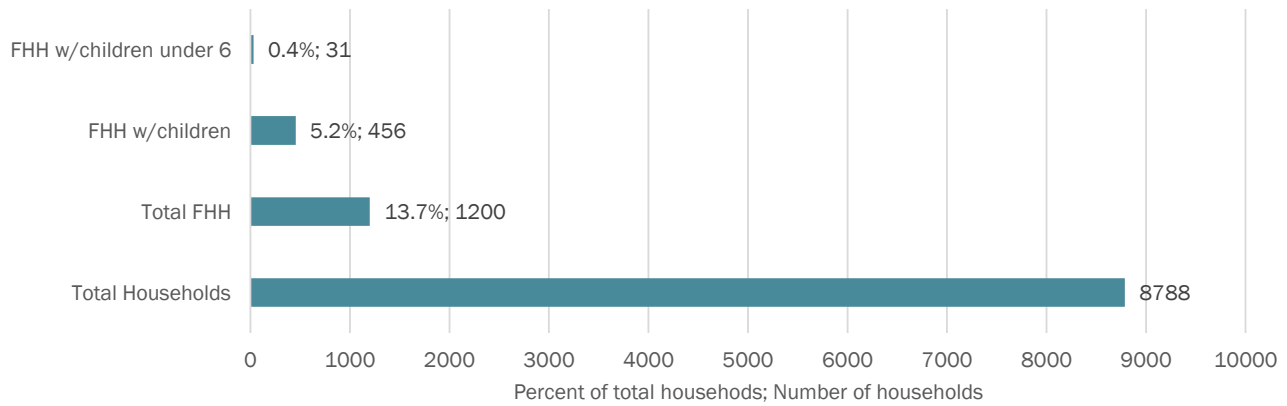
Households by Household Size

This chart illustrates the range of household sizes in Loma Linda for owners, renters, and overall. The most commonly occurring household size is of two people (34.4%) and the second-most commonly occurring household is of one person (28.2%). Loma Linda has a higher share of single-person households than the SCAG region overall (28.2% vs. 23.4%) and a lower share of 7+ person households than the SCAG region overall (1.7% vs. 3.1%).

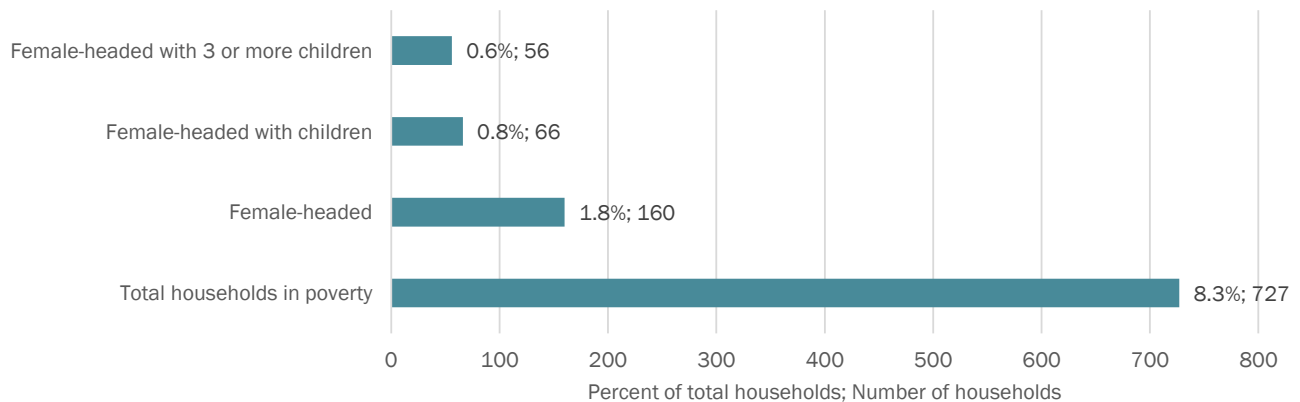
Female Headed Households (FHH)

Statute requires analysis of specialized housing needs, including female-headed households in an effort to ensure adequate childcare or job training services. Of Loma Linda's 8,788 total households, 13.7% are female-headed (compared to 14.3% in the SCAG region), 5.2% are female-headed and with children (compared to 6.6% in the SCAG region), and 0.4% are female-headed and with children under 6 (compared to 1.0% in the SCAG region).

Households by Poverty Status

8.3 percent of Loma Linda's households are experiencing poverty, compared to 7.9 percent of households in the SCAG region. Poverty thresholds, as defined by the ACS, vary by household type. More information can be found at M256. In 2018, a single individual under 65 was considered in poverty with a money income below \$13,064/year while the threshold for a family consisting of 2 adults and 2 children was \$25,465/year.

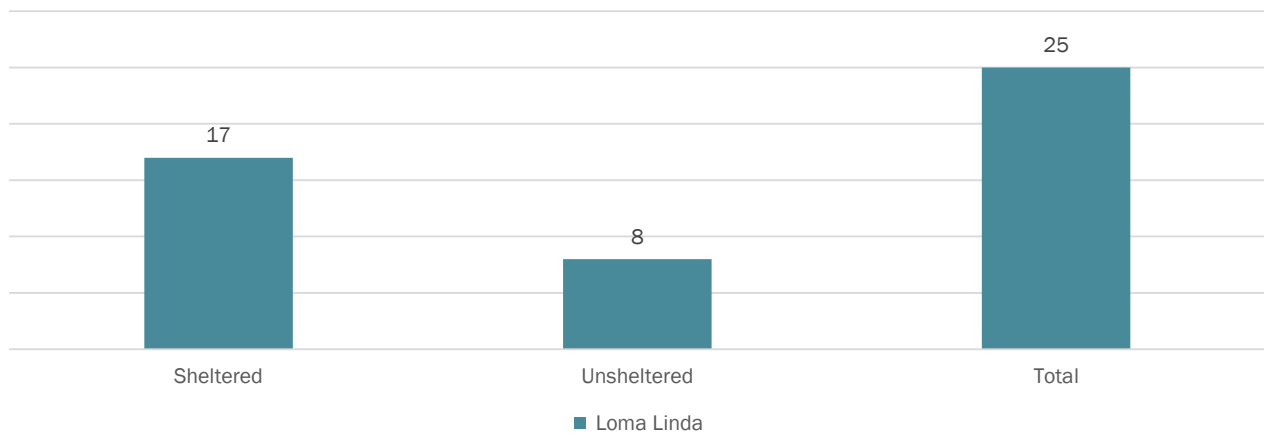

Statute requires analysis of specialized housing needs, including housing needs for seniors. Federal housing data define a household type as 'elderly family' if it consists of two persons with either or both age 62 or over. Of Loma Linda's 2,175 such households, 13.1% earn less than 30% of the surrounding area income, (compared to 24.2% in the SCAG region), 29.4% earn less than 50% of the surrounding area income (compared to 30.9% in the SCAG region).

III. PEOPLE EXPERIENCING HOMELESSNESS

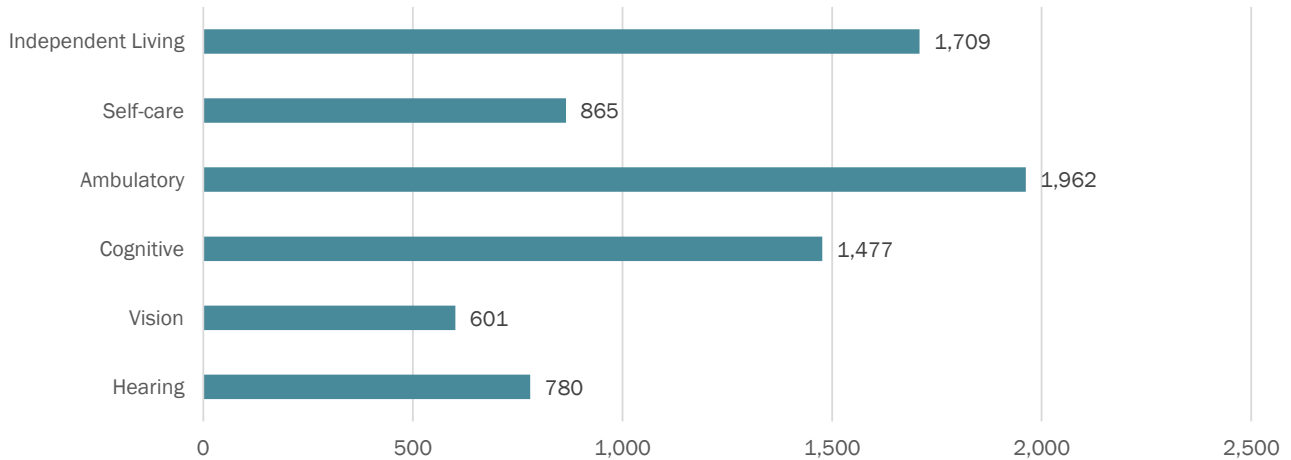

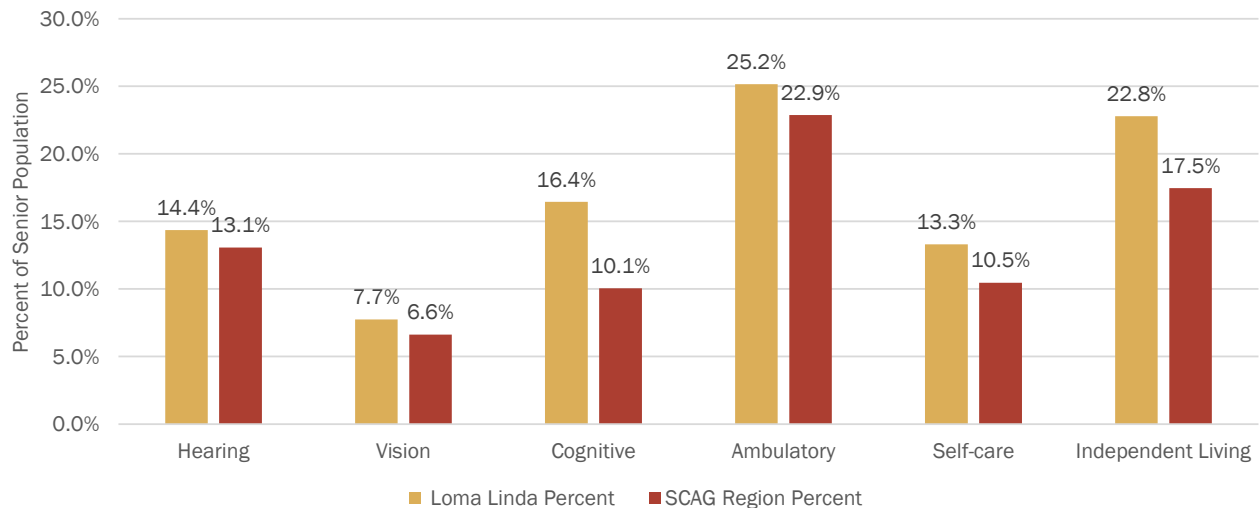
Disability by Type

Disability data also provides valuable context for assessing current and future need for accessible housing units. Note that since some disability types are not recorded for children below a certain age, calculating disability as a percentage of total population may not be accurate.

In Loma Linda, the most commonly occurring disability amongst seniors 65 and older was an ambulatory disability, experienced by 25.2% of Loma Linda's seniors (and 22.9% of seniors in the SCAG region).

Understanding the employment status of people with disabilities may also be an important component in evaluating specialized housing needs. In Loma Linda, 38.5% of the population with a disability is employed, compared to 66.1% of the non-disabled population.

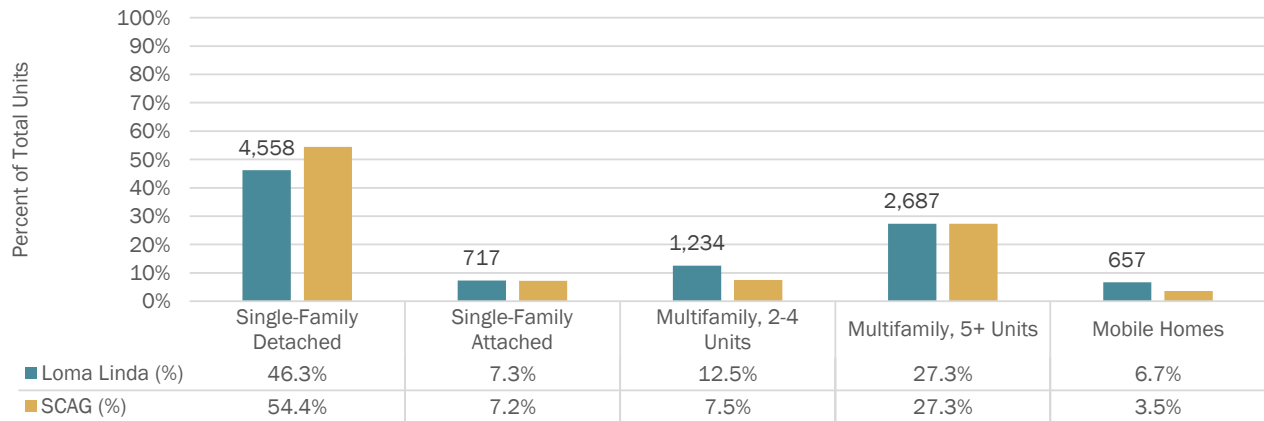

The California Department of Developmental Services also provides data on developmental disabilities by age and type of residence. These data are collected at the ZIP-code level and were joined to the jurisdiction-level by SCAG. Totals may not match as counts below 11 individuals are unavailable and some entries were not matched to a ZIP code necessitating approximation.

V. HOUSING STOCK CHARACTERISTICS

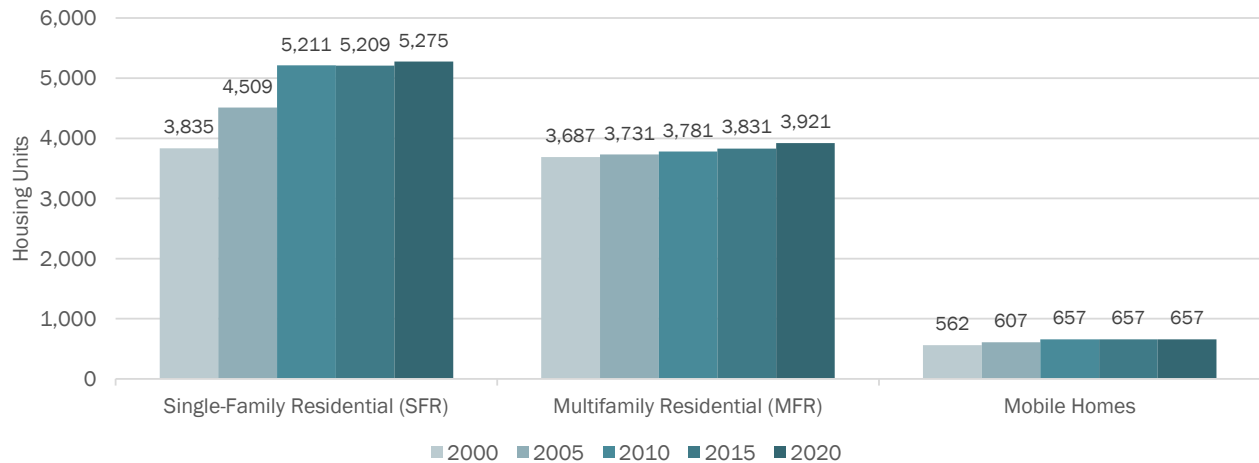
Housing Type

The chart above provides detailed information on the housing stock in Loma Linda, which has a total of 9,853 housing units. The most prevalent housing type in Loma Linda is single-family detached with 4,558 units. The share of all single-family units in Loma Linda is 53.5%, which is lower than the 61.7% share in the SCAG region. Out of the total housing units in Loma Linda, there are 9,155 occupied-units, which equates to a 7.1% total vacancy rate. The average household size (as expressed by the population to housing unit ratio) is 2.6.

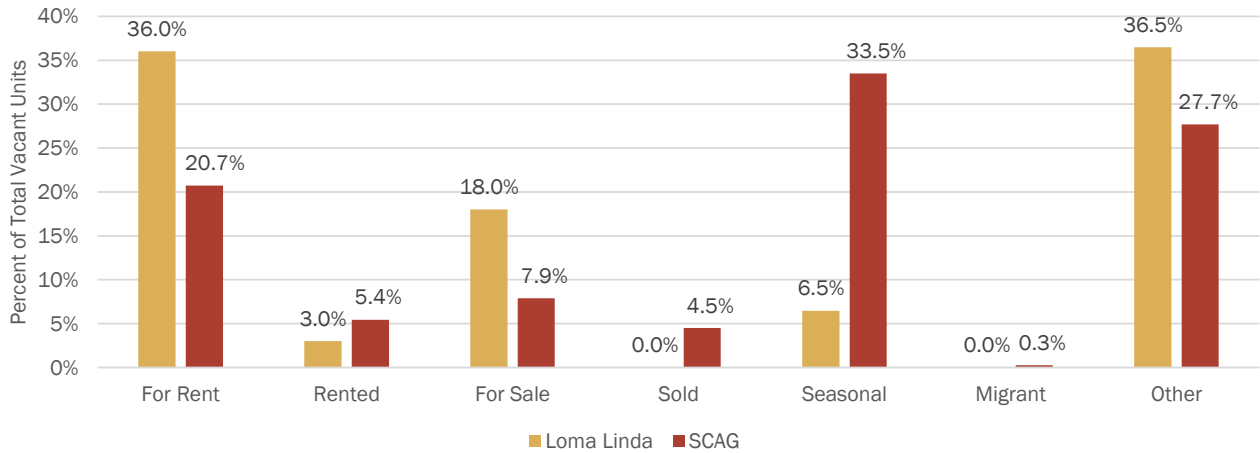
Housing Type Trend

Over the past two decades (2000-2020), there has been more construction of single-family residential units than multi-family residential units in Loma Linda. When comparing 2000 to 2020, SFR units increased by 1,440, MFR units increased by 234, and mobile units increased by 95.

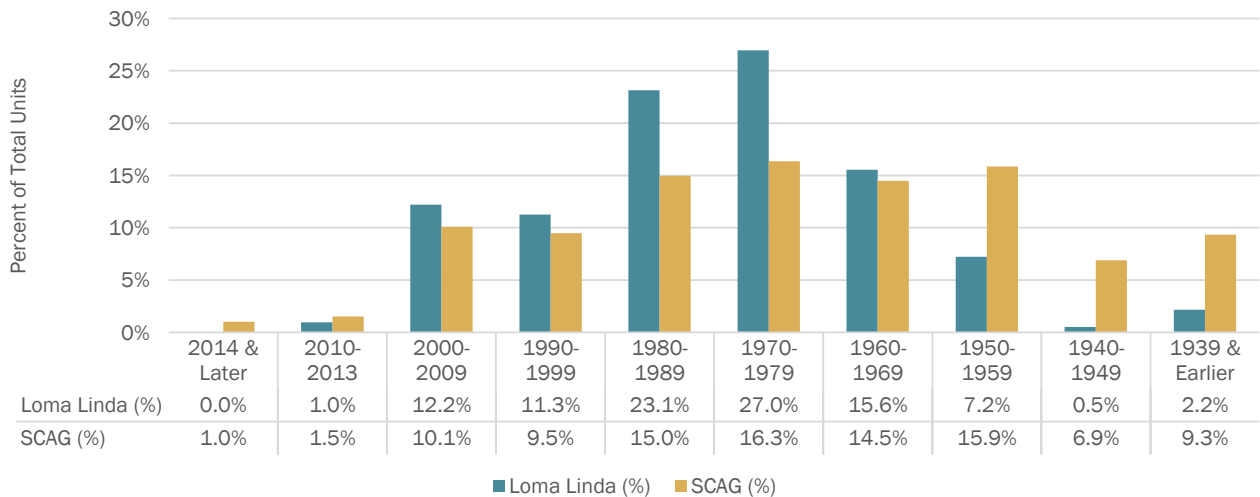
Vacant Units by Type

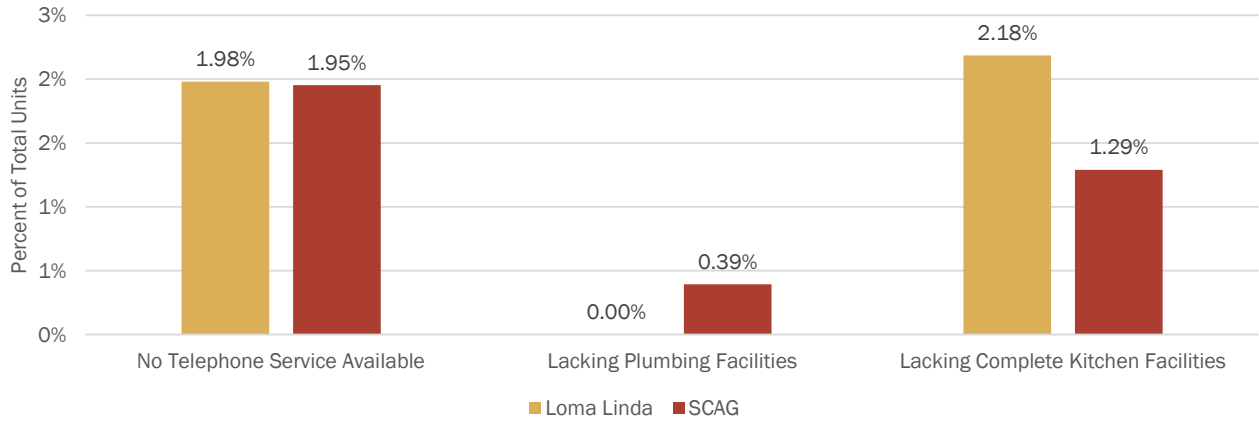
Housing Units by Year Structure Built

Examining the age of the current housing stock is one way to understand how historical development patterns have contributed to a city's form. The time period where the highest share of Loma Linda's housing units were built is 1970-1979, while in the SCAG region more units were built during 1970-1979 than any other period.

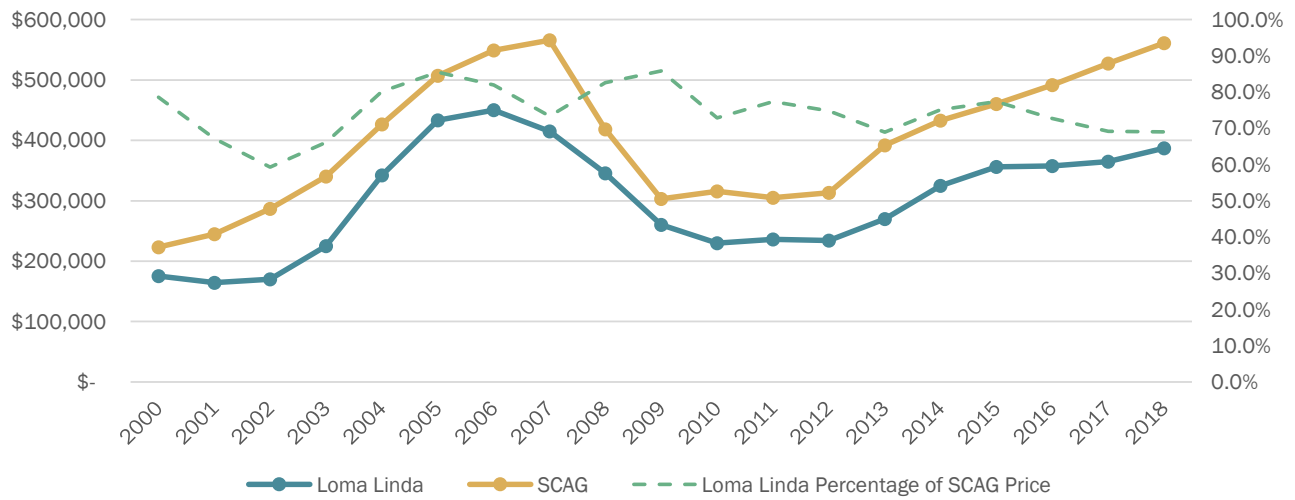
Substandard Housing

The ACS includes surveys about three factors of what may be considered substandard housing. In Loma Linda, 174 units lack telephone service, units lack plumbing facilities, and 192 units lack complete kitchen facilities.

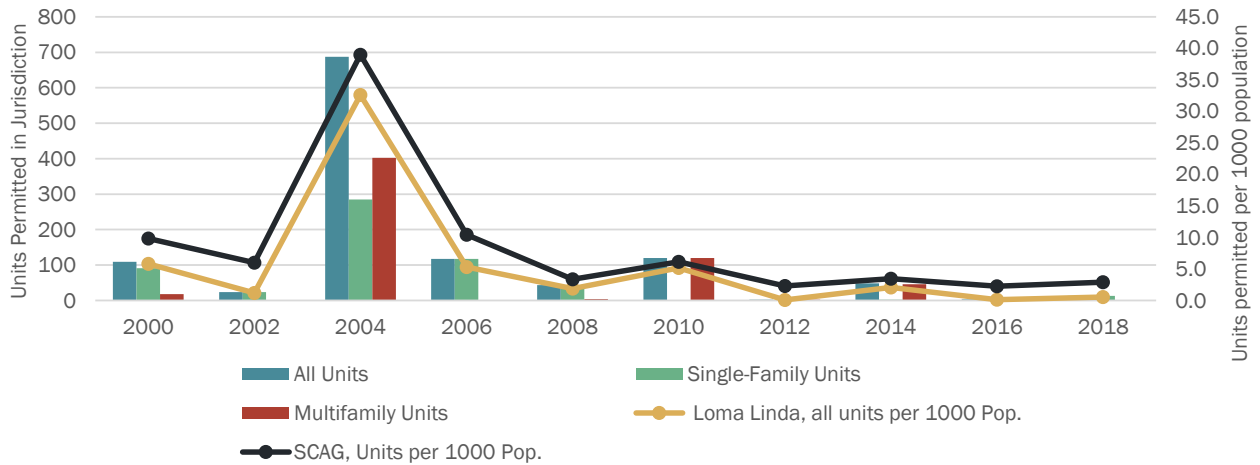
Median Home Sales Price for Existing Homes

Between 2000 and 2018, median home sales prices in Loma Linda increased 121% while prices in the SCAG region increased 151%. 2018 median home sales prices in Loma Linda were \$387,250 and the highest experienced since 2000 was \$450,000 in 2006. Prices in Loma Linda have ranged from a low of 59.3% of the SCAG region median in 2002 and a high of 85.8% in 2009.

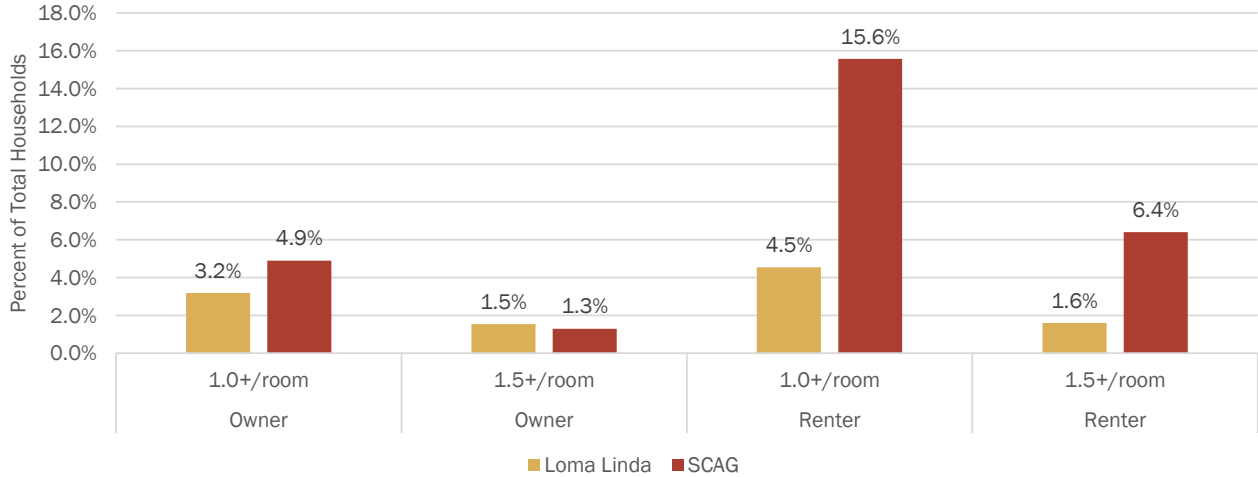
Housing Units Permitted

VI. OVERPAYMENT AND OVERCROWDING

Crowding by Extent and Tenure

In Loma Linda, 106 owner-occupied and 248 renter-occupied households had more than 1.0 occupants per room, which meets the ACS definition for overcrowding. 51 owner-occupied households and 87 renter-occupied households had more than 1.5 occupants per room, which meets the ACS definition for severe overcrowding.

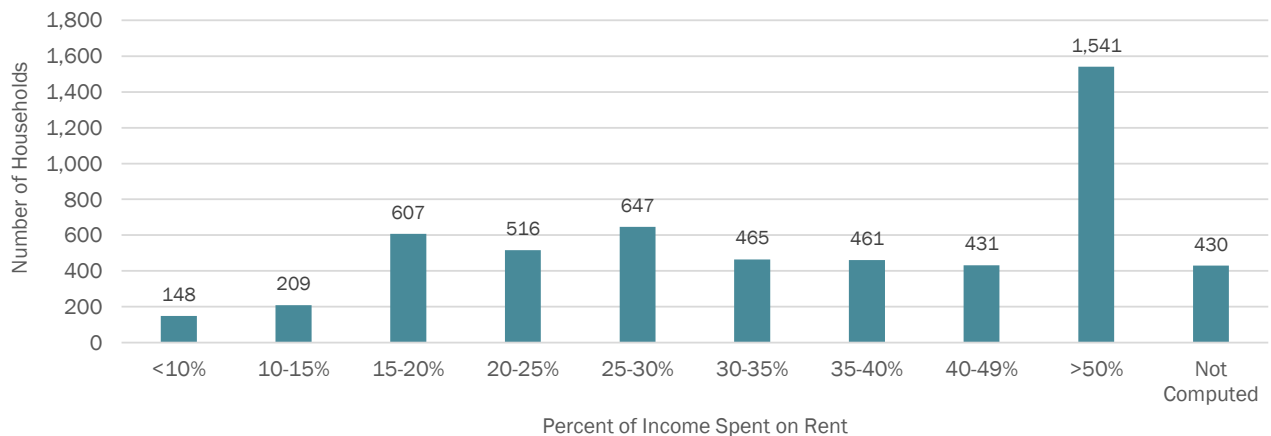

Housing cost burden is most commonly measured as the percentage of gross income spent on housing, with 30% a usual threshold for 'cost burden' and 50% the threshold for 'severe cost burden.' However, a lower-income household spending the same percent of income on housing as a higher-income household will likely experience more true 'cost burden.' These data indicate the number of households in Loma Linda by their income relative to the surrounding area and their share of income spent on housing.

Spending on Rent



Across Loma Linda's 5,455 renter households, 2,898 (53.1%) spend thirty percent or more of gross income on housing cost, compared to 55.3% in the SCAG region. Additionally, 1,541 renter households in Loma Linda (28.2%) spend fifty percent or more of gross income on housing cost, compared to 28.9% in the SCAG region.

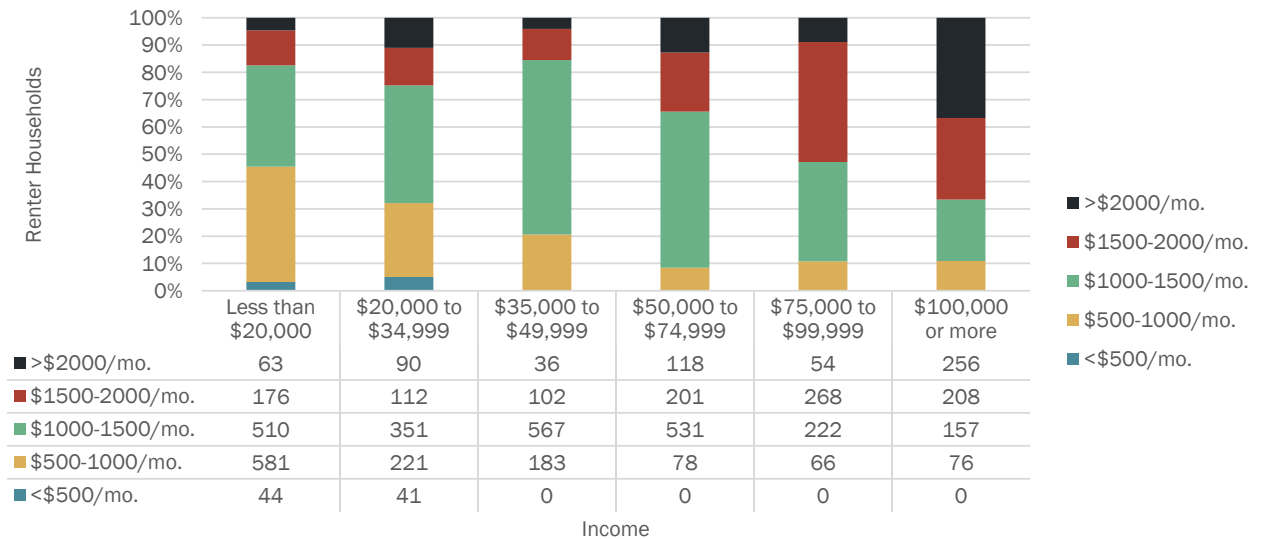
Spending on Rent by Income

While the previous table breaks down cost burden by area-relative income, the ACS also allows for the analysis of Loma Linda's 5,025 renter households (for which income data are available) by spending on rent by income bracket (dollar amounts). As one might expect, the general trend is that low-income households spend a higher share of income on housing (e.g. over 50%) while high-income households are more likely to spend under 20% of income on housing.

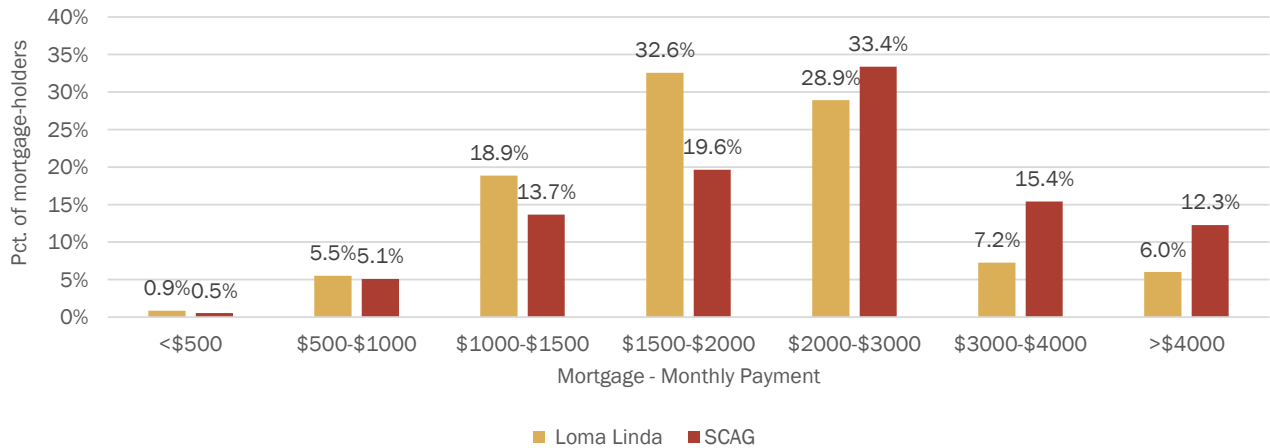
Household Income by (Cash) Rent

Loma Linda renter households' cash rent paid can be broken down by household incomes. As one might expect, the general trend is that lower-income households spend less on rent while higher-income households spend more on rent, though this may not be universally true. Rent categories range from <\$500/month (1.6% of Loma Linda renters) to >\$2000/month (11.6% of Loma Linda renters). The most common rent category in Loma Linda is \$1000-1500/month with 44% of renters.

Monthly Owner Costs for Mortgage Holders

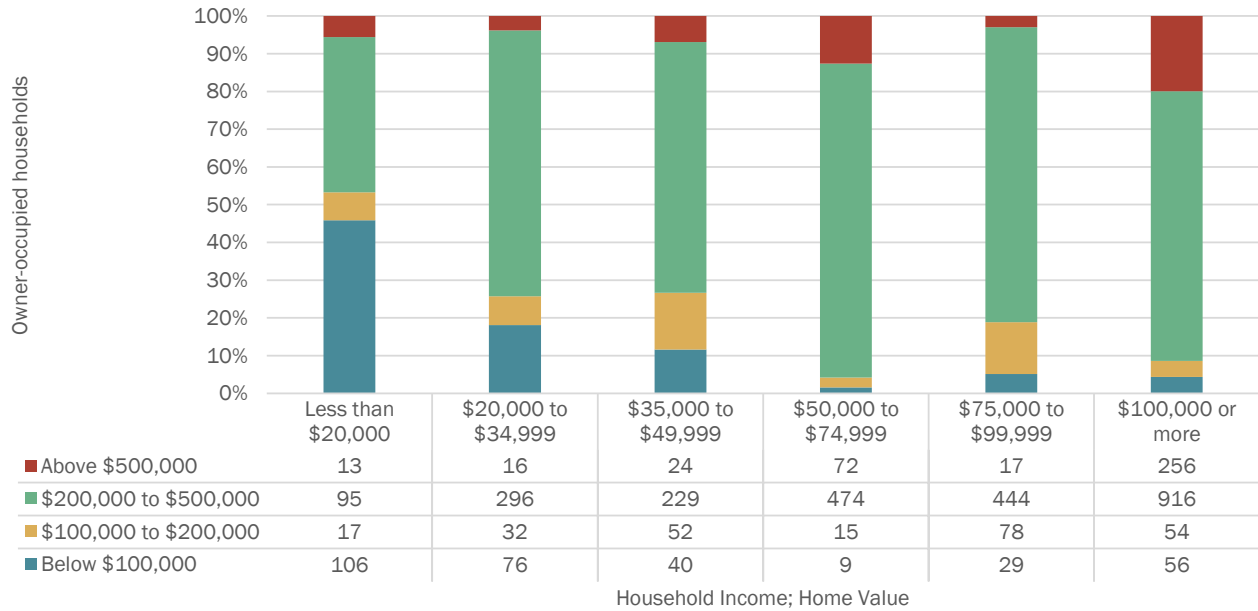
While renter households receive much of the focus when it comes to housing cost analysis, owner households make up 37.9% of Loma Linda and 52.5% of the SCAG region. The most commonly occurring mortgage payment in Loma Linda is \$1500-\$2000/month and the most commonly occurring mortgage payment in the SCAG region is \$2000-\$3000/mo.

Costs for Mortgage Holders by Income



Mortgage-holding households in Loma Linda can be broken down by income and the percentage of income spent on mortgage costs. As one might expect, the general trend is that lower-income households spend a higher share of income on housing costs, while high-income households may spend a lower share of income on housing. The income category most prevalent amongst Loma Linda mortgage-holding households is \$75,000 or more (1,365 households) and the most prevalent share of income spent on mortgage costs is 20-29% (661 households).

Household Income by Home Value (for owned units)



Another approach to evaluating the relationship between housing and income is to compare incomes and home values in Loma Linda. The most commonly-occurring income category amongst owner households in Loma Linda is \$100,000 or more (1,282 households) and the most commonly-occurring home value category is \$200,000 to \$500,000 (2,454 households).

Housing the extremely-low income population (below 30% of area median income) can be especially challenging. HUD's CHAS dataset provides a wealth of information on such households in Loma Linda. The above table provides a breakdown of extremely low income households by race and ethnicity. The race/ethnicity with the highest share of extremely-low income households in Loma Linda is Black, non-Hispanic (30% compared to 16.7% of total population). In the SCAG region, the highest share of extremely-low income households is Black, non-Hispanic (27.1% compared to 17.7% of total households).

The California Housing Partnership (CHP) provides data on assisted housing units and assesses the level of risk to converting to market rate. These data identify homes without a known overlapping subsidy that would extend affordability beyond the indicated timeframe and unless otherwise noted are not owned by a large/stable non-profit, mission-driven developer.
