



CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Hon. Pam O'Connor, Chair, called the meeting to order at 10:04 a.m.

That way, staff can quickly present background information for the meeting and then speakers' presentations can lead directly to an engaged dialogue.

CONSENT CALENDAR

Approval Items

Approve Minutes from October 2, 2012 Sustainability Subcommittee Meeting

A MOTION was made (Chen) to approve the consent calendar. The MOTION was seconded (Graham) and UNANIMOUSLY APPROVED. Roll-call was taken and the item was unanimously approved.

INFORMATION ITEMS

5. Review of Sustainability Subcommittee Draft Policy Recommendations

Hon. Pam O'Conner stated that the Sustainability Subcommittee needs to determine what level of action it wants to take moving forward, such as whether the subcommittee wants to make specific action recommendations or alternatively suggest general areas that require more research. The subcommittee recommendations will be delivered to the Community, Economic and Human Development Committee (CEHD) and then go to the Regional Council (RC). If the subcommittee does not have any specific recommendations, the subcommittee will want to deliver tangible material to enable the policy committees to keep dialogue going on significant topics and issues. Marco Anderson, SCAG staff, briefed the subcommittee on the key points, definition, and goals of the sustainability framework matrix.

2. Review Definitions of "Sustainability"

Marco Anderson, SCAG staff, stated that SCAG circulated an internal e-mail which tapped into staff's intellectual capital to come up with some original and already existing definitions of "Sustainability." The definitions of "Sustainability" as put forth by staff are comprised into three main areas. One of the areas is referred to as the 3-E's: environment, economy, and equity. It is important to remember that the 3-E's share importance regardless of how you state them, they should be co-equal. Other staff defined sustainability as the 3-P's: people, places, and profit. The third aspect that all the definitions share is a component of time. Sustainability is not something that takes place at one point in time but rather balances the present with the future. How to get that balance is something this subcommittee is tasked with considering, which is to look at the component of time and some level of environmental constraint.

3. <u>Review 2012-2035 Regional Transportation Plan/Sustainable Community Strategies (RTP/SCS) Housing Typology Assumptions</u>

Jacob Lieb provided a review of the housing typology assumptions used for the 2012 RTP/SCS. The plan development process featured a substantial amount of analysis and public dialogue. The key conclusion was that the housing market is moving away from predominantly large lot single family homes and toward smaller lots and multifamily homes. The extent of this shift is potentially dramatic but ultimately

debatable. The direction of the shift is generally agreed to by most stakeholders. This conclusion was reflected in the assumptions for the adopted 2012 RTP/SCS.

4. Establish Future Subcommittee Meeting Dates

Hon. Pam O'Connor announced that the next meeting of the Sustainability Subcommittee will be a joint meeting of the Sustainability, Public Health and the Active Transportation Subcommittees. The meeting will be held on Monday, January 14, 1:00–3:00 p.m.

5. Future Trends in the Real Estate Development, Building, and Leasing Industries

David Shepherd, Chief Executive Officer (CEO) of the Building Industry Association (BIA), briefed the subcommittee on the current state of the home building industry and the benefits of new development for sustainability. Mr. Shepherd also talked about ideas for the subcommittee to consider and some suggestions for SCAG and its policy makers.

Mr. Mott Smith, representing the California Infill Builders Association (CIBA) briefed the subcommittee on the challenges facing infill development and the goal of the CIBA which is to promote the business of building more sustainable projects in urban areas throughout California. He also provided comments on what the CIBA believes would help promote infill which includes eliminating parking minimums, planning for infrastructure, and fixing the California Environmental Quality Act (CEQA).

Mr. David Pogue, Global Director of Sustainability for CB Richard Ellis (CBRE), gave the subcommittee some background on CBRE and its real estate holdings. Mr. Pogue also provided his thoughts on how corporate and institutional America is looking at the next generation of office building development that is being driven by location efficiency, energy efficiency, integrated with where people live, more density, opportunity for daytime and nighttime use, and what clients are seeking in carbon footprint counting.

CHAIR'S REPORT

Hon. Pam O'Conner stated that staff had prepared a list of seven policy framework discussion questions which the subcommittee did not get to discuss today. Hon. Pam O'Conner suggested that staff e-mail the questions to the subcommittee members and anyone who is interested at today's meeting. If there are any comments or thoughts about any of the questions, members should contact staff via e-mail and the comments can be addressed at the next meeting or staff can prepare a summary.

Sustainability Subcommittee Policy Staff Recommendations

Goals and Guiding Policies were included in the 2012-2035 Regional Transportation Plan/Sustainable Communities Strategy. In order to assist in meeting the goals and guiding policies, six subcommittees were convened to help guide SCAG as it implements the 2012-2035 RTP/SCS and begins to lay the foundation for the 2016 RTP/SCS. These six subcommittees focus on different components that were strongly advocated for during the development of the last RTP/SCS.

At the commencement of the Sustainability Subcommittee, five components were presented for members to consider, discuss and define for a final deliverable to the SCAB Policy Committees. The components were: definitions, needs assessments, performance measures, strategy, and investments. Four subcommittee meetings were held and dialogue was held on the five components presented, the considerations for each component, and potential recommendations/actions were provided. The following four recommendations represent the output of comments and discussions held at the first three meetings of the Sustainability Subcommittee along with input provided by ex-officio members and stakeholders. These recommendations are intended to strengthen the implementation of the 2012-2035 RTP/SCS and development of the 2016-2040 RTP/SCS. These recommendations are not final, but rather will be taken to Policy Committees, and eventually to the Regional Council for deliberation and potentially for adoption.

Improve and expand the availability of data and information to evaluate the RTP/SCS and its alternatives relative to sustainability.

- Catalogue current performance monitoring and measurement indicators and identify better, cost-effective methods for using them to refine RTP/SCS scenario comparisons
- Develop and refine performance metrics for location efficiency in order to measure development siting impacts, such as jobs / housing fit
- Identify sustainability goals beyond transportation and land use, and where practical, identify regional partners to work with to achieve those goals e.g. water, energy, habitat conservation

Next Steps: In consultation with the Plans & Programs Technical Advisory Committee (P&PTAC), modeling experts, and other partners determine performance monitoring and measurement best practices that can be adopted. Continue improving performance monitoring program.





Sustainability Subcommittee Policy Staff Recommendations

At the commencement of the Sustainability Subcommittee, five components were presented for members to consider, discuss and define for a final deliverable to the SCAG Policy Committees. The components were: definitions, needs assessments, performance measures, strategy, and investments. Four subcommittee meetings and dialogue was held on the five components presented, and potential recommendations/actions were provided. The following four recommendations represent the output of comments and discussions held at the meetings of the Sustainability Subcommittee along with input provided by ex-officio members and stakeholders. These recommendations are intended to strengthen the on-going implementation of the 2012-2035 RTP/SCS and development of the 2016-2040 RTP/SCS. These recommendations are not final, but rather will be taken to Policy Committees, and eventually to the Regional Council for deliberation and potentially for approval.

 Develop a definition of sustainability which recognizes the importance of local decision making, yet fosters regionally significant sustainability goals (discuss and decide among the following choices)

Option 1-Sustainability- We work with our partners and local governments to achieve a quality of life that provides resources for today's generation while preserving an improved quality of life for future generations

Option 2- Sustainable development is development that meets the needs of the present without compromising the ability of future generations to meet their own needs

Option 3- Living with future generations and nature in mind, as well as sharing the benefits of economic growth in justice

Option 4- Reduce statewide greenhouse gas emissions to 1990 levels by 2020

Next Steps: Disseminate local definition throughout the organization, and its deliberative bodies. Pending further discussion and action by CEHD and Regional Council include language in drafting the 2016-2040 RTP/SCS.

2. Consider and refine the availability of data and information to evaluate the RTP/SCS and its alternatives relative to sustainability, as defined

- Provide technical foundation for any potential improvements to performance measures and indicators by conducting research and identifying best methods for RTP/SCS alternatives evaluation and monitoring
 - Focus on strengthening the location efficiency indicator to guide sustainable development including, for example, jobs / housing fit and active transportation accessibility to neighborhood services
- Develop performance monitoring program for tracking 2012-2035 RTP/SCS implementation

Next Steps: In consultation with technical working groups, modeling experts, and other partners determine performance monitoring and measurement best practices for consideration. Continue improving the performance monitoring and assessment program.

3. Support regulatory framework and project delivery financing that allows for sustainable development

- Provide local examples of workable CEQA practices to statewide entities engaged in CEQA modernization discussions
- Engage in the development of replacement local investment tools for Community Redevelopment Agencies (CRA)
- Continue to support research, and/or dissemination of best practices (e.g. through Sustainability Program grants) of dynamic local regulation of Parking, Multi-Modal Level of Service, and Complete Street Standards

Next Steps: Report to Legislative Committee. Identify and assist local agencies that are adopting available CEQA amendments and local jurisdictions implementing alternative financing. Train local planners through SCAG Programs. Develop model ordinances and sample policy language through relevant Compass Blueprint Demonstration Projects. Promote the California Infrastructure Funding & Financing website that SCAG developed through the Compass Blueprint Program.

In addition to these three areas the Sustainability Committee found common ground with the Active Transportation and Public Health Subcommittees in supporting the promotion of Active Transportation.

4. Seek opportunities to promote transportation options with an active component/physical activity

- Support goals and principles of Active Transportation Work Plan, as it pertains to sustainability
- Promote active transportation as a means to encourage active and healthy lifestyles
- Support and seek opportunities to promote safety in active transportation

Next Steps to 2016 RTP/SCS Development: Develop cost effective investments and strategies that promote active life style as part of 2016 RTP/SCS development process, subject to further stakeholder input and technical review, and work with transportation finance division to quantify costs and identify funding. This will be discussed further at Joint Meeting #6 with the Active Transportation, Public Health and Sustainability Subcommittees.

DIRECTOR'S APPROVAL:

EXECUTIVE SUMMARY:

Staff has developed a consolidated Sustainability Program "call-for-projects" grant program, as called for in the FY 2013/14 Overall Work Program (OWP). As previously reported to the Policy Committees, the goal of the Sustainability Program is to build on the success of the Compass Blueprint effort to provide additional member services for communities and partners with two new components - Active Transportation and the Green Region Initiative. As such, the new Sustainability Program will contain three components - the two new components in addition to Compass Blueprint. Project selection criteria will be used to evaluate grant proposals and rank them for available funding.

The Active Transportation component will provide funding to plan and facilitate bicycle and pedestrian projects and programs in the region. Compass Blueprint grants will continue to focus on integrated land use and transportation planning. The Green Region Initiative component will provide grants to assist local jurisdictions in funding sustainability plans or studies, such as climate action plans and water, energy, or open space studies. A new consolidated "call-for-projects" will solicit project proposals for Active Transportation, Compass Blueprint, and the Green Region Initiative projects. The Sustainability Program Call for Projects criteria are being presented simultaneously to the three Policy Committees due to CEHD's on-going oversight of Compass Blueprint, EEC's role in the development of the Green Region Initiative, and TC's role in Active Transportation. The Policy Committees' recommendations will be presented to the Regional Council on March 7, 2013.

The intent is to grow the Sustainability Program each year. After the release of the "call-for-projects" in early March 2013, this program will begin in mid-2013. Proposed projects will be evaluated and selected based on the criteria presented in this Staff Report.

STRATEGIC PLAN:

This item supports SCAG's Strategic Plan Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; and Goal 4: Develop, Maintain and Promote the Utilization of State of the Art Models, Information Systems and Communication Technologies.

BACKGROUND:

Since 2004, Compass Blueprint has been a successful component of SCAG^{**}s efforts to assist local jurisdictions and implement RTP/SCS policies. To date, 133 Compass Blueprint-funded local planning projects have been completed or are currently in progress. Each of these Demonstration Projects provides an example of integrated transportation and land use planning, tailored to local needs and aligned with regional priorities that other cities and counties can emulate.

At the May 2011 SCAG General Assembly, Executive Director Hasan Ikhrata announced that SCAG would initiate a Green Region Initiative, a key element of SCAG"s ongoing sustainability work, with funding to assist jurisdictions. The Green Region Initiative is part of a package of post-RTP/SCS follow-up activities, including Active Transportation, to assist local jurisdictions and others in implementing strategies identified in the RTP/SCS. The Green Region Initiative will join Active Transportation and Compass Blueprint in providing small grants to member jurisdictions to carry out a full suite of planning activities that help make the SCAG region more sustainable and implement the approved 2012-2035 RTP/SCS.

In coordination with the existing Compass Blueprint effort, a consolidated Sustainability Program "call-for-projects" has been developed by SCAG staff to help fund innovative approaches to solving regional issues. The "call-for-projects" will be released in March 2013, with work on approved projects to begin on or near the start of Fiscal Year 2013-2014. Pending review and approval by the Policy Committees and the Regional Council, project proposals will be evaluated and selected based on the criteria below. We anticipate approximately \$1 million in total funding will be available as part of this call for projects.

Staff is seeking approval of the ranking criteria for the call for projects and has placed emphasis on the following:

- Rollout of the Sustainability Program, including new Active Transportation and Green Region components, along with the on-going Compass Blueprint component
- Assistance in updating local General Plans consistent with RTP/SCS strategies
- Implementation of the 2012-2035 RTP/SCS
- Cross-jurisdictional and multi-party collaborations
- Promoting ,on-the-ground" implementation of the 2012-2035 RTP/SCS

Proposed 2013 Project Ranking Criteria:

General (for all projects): [70 points]

- SCAG membership
- Demonstrates reasonable commitment to implement the project
- Implements the 2012-2035 RTP/SCS
- Promotes or encourages sustainability (3 E"s: Economy, Equity and Environment)
- Demonstrates a clear need for the project and requested services
- Involves public and private and/or cross-jurisdictional partnerships
- Demonstrates innovative approaches to regional planning issues that can be replicated elsewhere
- Leverages other public and private funding sources
- Outlines a realistic timeline

For Compass Blueprint Projects: [30 points]

- Integrates land use and transportation planning
- Promotes infill, Transit Oriented Development (TOD), and other forms of sustainable development
- Promotes a sustainable land use mix, including new housing

For Green Region Initiative projects: [30 points]

- Addresses climate change through GHG emission reduction or adaptation planning
- Promotes energy and/or water efficiency and savings
- Promotes overall sustainability on various resource issues

For Active Transportation projects: [30 points]

- Promotes Active (Bicycle and Pedestrian) Transportation Planning
- Promotes physical activity
- Promotes linkages within existing active transportation and transit networks
- Promotes safety, education and outreach

FISCAL IMPACT:

Funding for the selected projects resulting from the Sustainability Program's Call for Projects is proposed as part of the draft FY 13-14 Overall Work Program (OWP) Budget, which includes \$500,000 from a Strategic Growth Council grant awarded to SCAG. Funding of any work for FY 13-14 is contingent upon approval of the OWP Budget and availability of funding. Staff's work for the current fiscal year is included in FY 12-13 OWP 13-225.SCG01641E.01 and 13-065.SCG00137.01.
