## **MEETING SUMMARY**

## 1. CALL TO ORDER AND SELF-INTRODUCTIONS

Rabindra Bade, TCWG Chair, called the meeting to order at 10:02 a.m.

### 2. PUBLIC COMMENT PERIOD

None.

### 3. **CONSENT CALENDAR**

3.1. May 28, 2024 TCWG Meeting Minutes The meeting minutes were approved.

### 4. INFORMATION ITEMS

- 4.1. Review of PM Hot Spot Interagency Review Forms
  - 3M10WT03: it was reaffirmed that this project is not a project of air quality concern.
  - RIV060109: it was reaffirmed that this project is not a project of air quality concern.

Erika Espinosa Araiza, Caltrans HQ, noted that TCWG was moving away from circulating information and concurrences via e-mails after meetings. All TCWG concurrences must occur at the meeting.

## 4.2. RTP Update

Agustin Barajas, SCAG, reported the following:

- On June 6, 2024, SCAG's Regional Council approved the public release of draft Amendment No. 1 to Connect SoCal 2024 in conjunction with the draft 2025 FTIP, including the associated federally required draft transportation conformity analyses.
- The 30-day public review and comment period would begin July 12, 2024 and end August 12, 2024.
- SCAG's Regional Council would consider the proposed final Amendment No. 1 to Connect SoCal 2024 and the proposed final 2025 FTIP, including the associated proposed final transportation conformity analyses for approval in Fall 2024. Federal approval was anticipated in December 2024.

### 4.3. FTIP Update

Agustin Barajas, SCAG, reported the following:

- The 2023 FTIP Administrative Modification No. 23-29 was approved on May 31, 2024.
- SCAG staff were reviewing and finalizing the 2023 FTIP Amendment No. 23-30 and Administrative Modification No. 23-31, which included programming updates from SCAG's call for projects for STBG, CMAQ, and CRP federal funding.
- The next 2023 FTIP amendment opportunities would be Administrative Modifications No. 23-32 and Amendment No. 23-33, which would be due to SCAG staff on July 9, 2024 and July 16, 2024, respectively.

### 4.4. EPA Update

Karina O'Connor, EPA, reported the following:

- EPA was tracking multiple sanctions clocks for the SCAG region. Many clocks were paused with EPA actions, as reported at previous TCWG meetings.
- Two highway sanctions clocks were related to the new source review (NSR) rules in the MDAQMD and the AVAQMD, and two highway sanctions clocks were related to failure to submit the required SIPs by the South Coast AQMD.
- MDAQMD's litigation concerning its NSR rules would affect EPA's ability to turn off the highway sanction clock. Oral



- arguments were scheduled for August 2024. However, the Federal Implementation Plan (FIP) for the NSR rules would be due in November 2024. EPA was working on and would publish the FIP by that deadline.
- Regarding the failure to submit the required PM2.5 SIP elements for the 2012 annual PM2.5 standard in the South Coast Air Basin, South Coast AQMD had adopted the said SIP on June 7, 2024 but had not yet submitted to EPA through CARB.
- There was another pending highway sanction clock that had not begun but was expected to begin soon. It was related to EPA's proposed disapproval of South Coast AQMD's Clean Air Act 182(e)(5) Contingency Measure Plan for the 1997 8-hour ozone standard. EPA was under a consent decree to finalize that proposed action by the end of July 2024.
- 4.4.1. Status Update on the SCAQMD Lawsuit against EPA (Case No. 2:23-cv-02646) Michael Dorantes, EPA, reported no updates.

### 4.5. ARB Update

Lijin Sun, SCAG, reported the following on behalf of CARB staff:

- CARB staff was developing the next version of the EMFAC model, also known as EMFAC202Y. The alpha version for EMFAC202Y would be released in July 2024 for MPOs to review and testing purposes and to provide feedback.
   CARB staff would share the link once it became available.
- CARB staff also completed the VMT offset demonstration and motor vehicle emissions budgets (MVEBs) for the Coachella Valley Extreme nonattainment area 75 ppb ozone SIP. This item would be presented to TCWG for interagency consultation at the July TCWG meeting.
