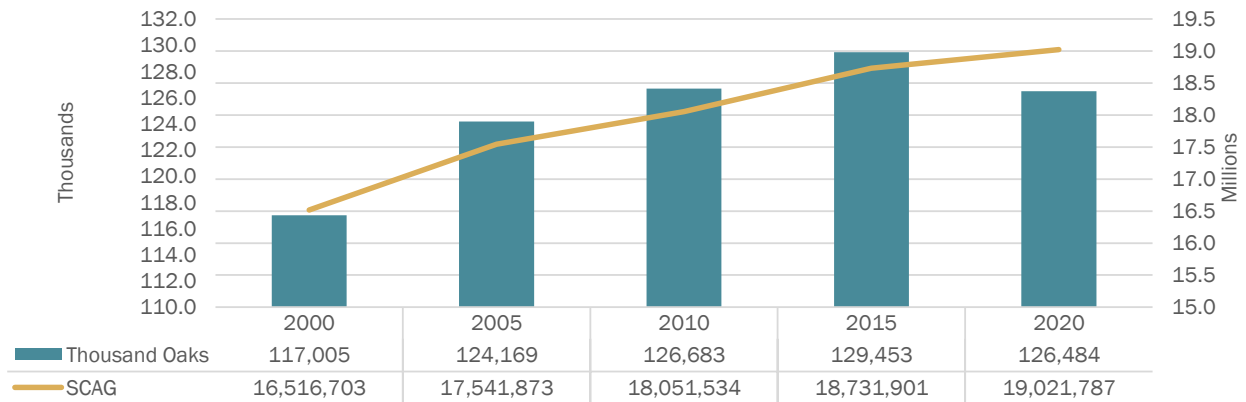
## Pre-Certified Local Housing Data for Thousand Oaks

Developed by SCAG and pre-certified by the California Department of Housing and Community Development (HCD) for use in 6th cycle housing elements.

This report contains a wide range of jurisdiction-level data elements intended to provide an understanding housing need experienced in Thousand Oaks as a part of its 6th cycle housing element update. Data sources are noted below each table or figure.

### I. POPULATION, EMPLOYMENT, AND HOUSEHOLDS

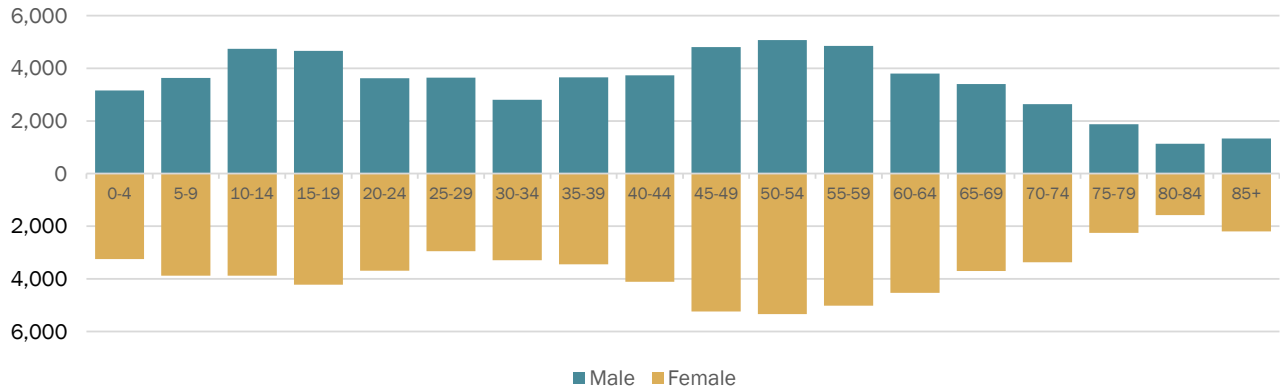
#### Population Trend, 2000-2020

Thousand Oaks has a 2020 total population of 126,484 including 1,742 living in group quarters according to the California Department of Finance. The chart above describes the population trend in Thousand Oaks from 2000 to 2020. Over this period Thousand Oaks had an annual growth rate of 0.4% compared to 0.7% for the region.

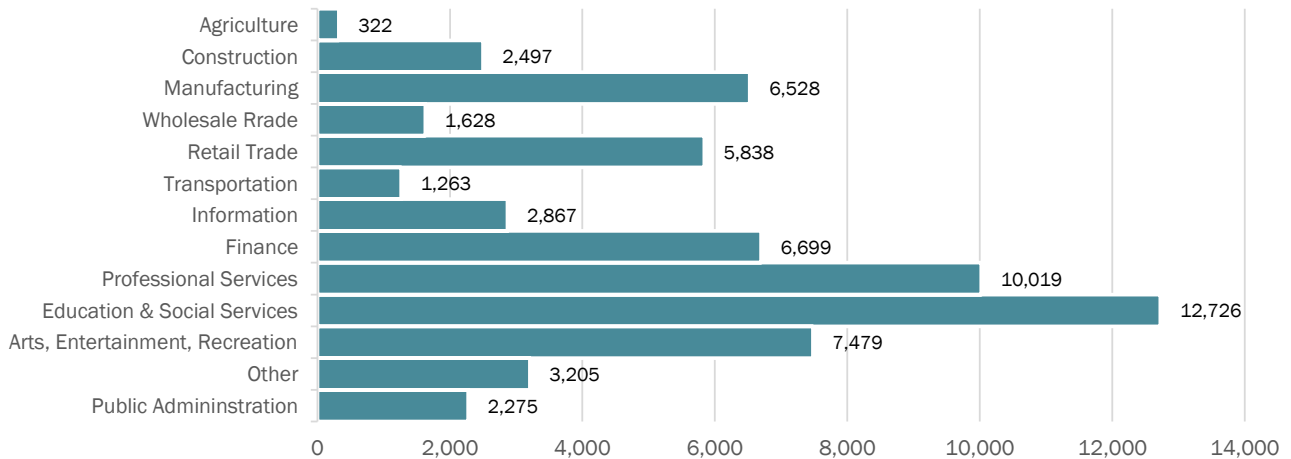
### Current Population by Age and Sex

The population of Thousand Oaks is 48.7% male and 51.3% female. The share of the population of Thousand Oaks which is under 18 years of age is 21.9%, which is lower than the regional share of 23.4%. Thousand Oaks's seniors (65 and above) make up 18.3% of the population, which is higher than the regional share of 13%.

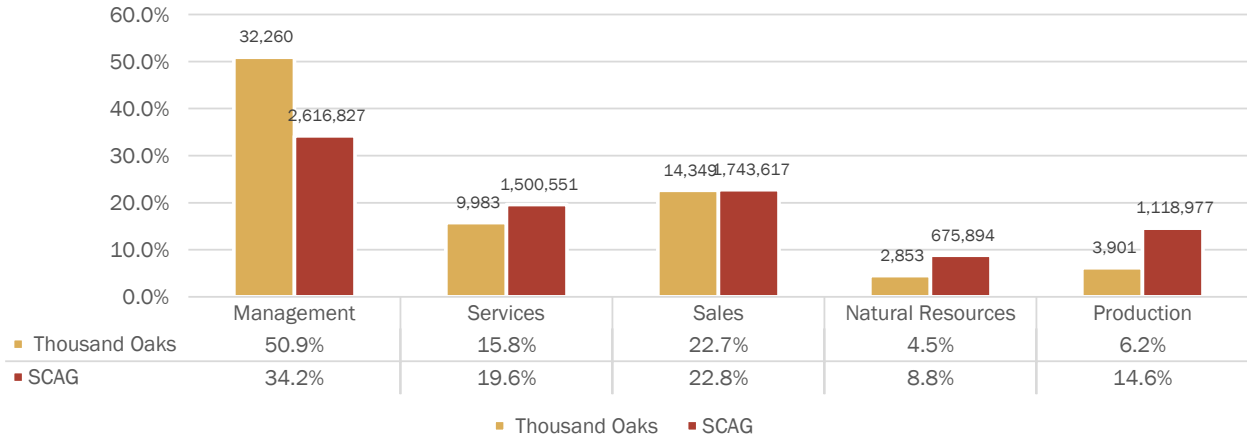
### Employment by Industry

Thousand Oaks has 63,346 workers living within its borders who work across 13 major industrial sectors. The chart above provides detailed employment information. The most prevalent industry is Education & Social Services with 12,726 employees (20.1% of total) and the second most prevalent industry is Professional Svcs. with 10,019 employees (15.8% of total).

## Employment by Occupation

In addition to understanding the industries in which the residents of Thousand Oaks work, it is also possible to analyze the types of jobs they hold. The most prevalent occupational category in Thousand Oaks is Management, in which 32,260 (50.9% of total) employees work. The second-most prevalent type of work is in Sales, which employs 14,349 (22.7% of total) in Thousand Oaks.

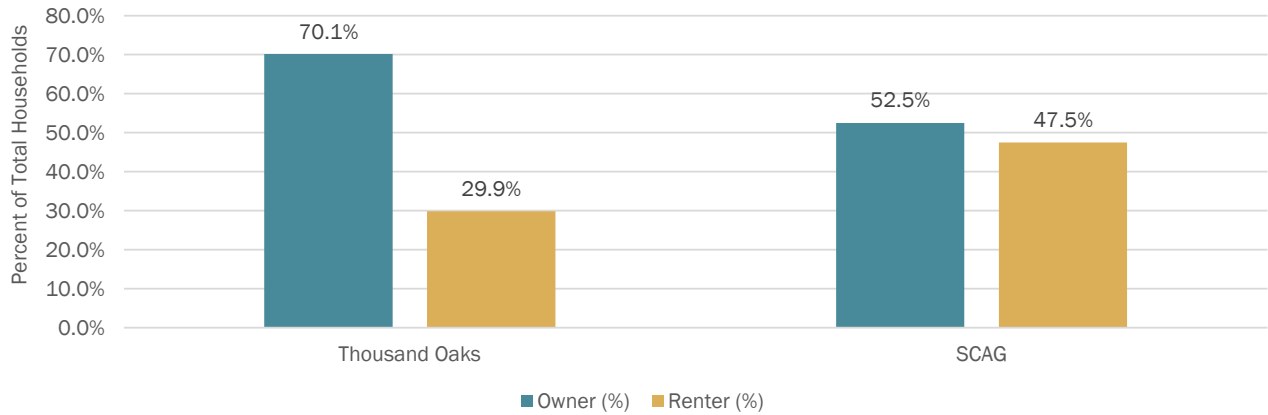

Statewide, farmworker housing is of unique concern and of unique importance. While only a small share of SCAG region jurisdictions have farmworkers living in them, they are essential to the region's economy and food supply.

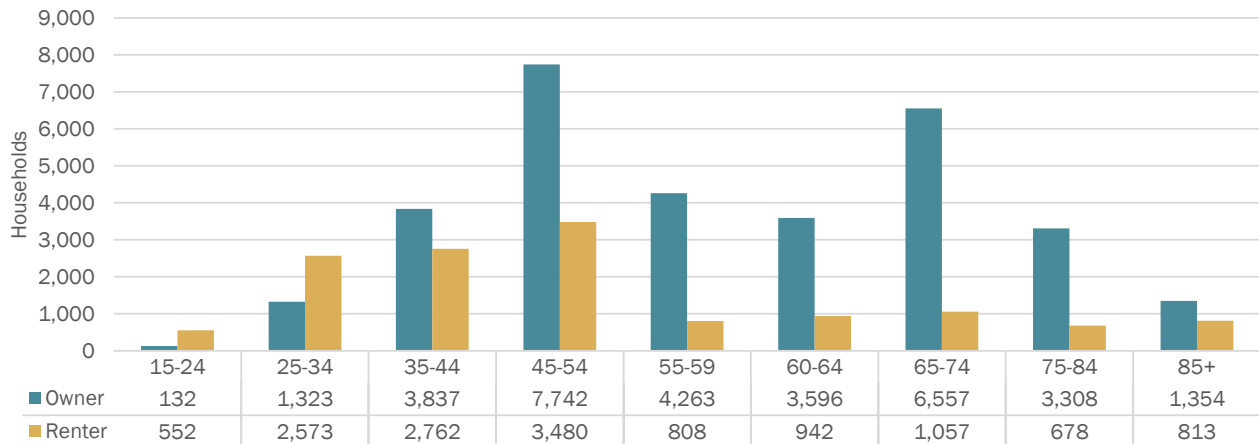
## Housing Tenure

Housing security can depend heavily on housing tenure, i.e. whether homes are owned or rented. Thousand Oaks's housing stock consists of 45,777 total units, 32,112 of which are owner-occupied and 13,665 of which are renter-occupied. The share of renters in Thousand Oaks is lower than in the SCAG region overall.

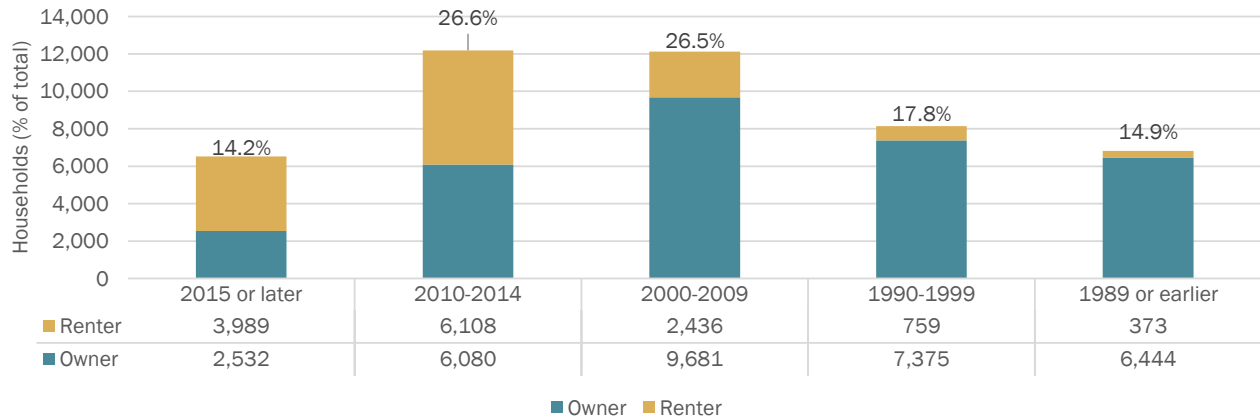
## Housing Tenure By Age

In many places, housing tenure varies substantially based on the age of the householder. In Thousand Oaks, the age group where renters outnumber owners the most is 15-24 (by 61.4%). The age group where owners outnumber renters the most is 65-74 (by 72.2%).

## Housing Tenure by Year Moved to Current Residence

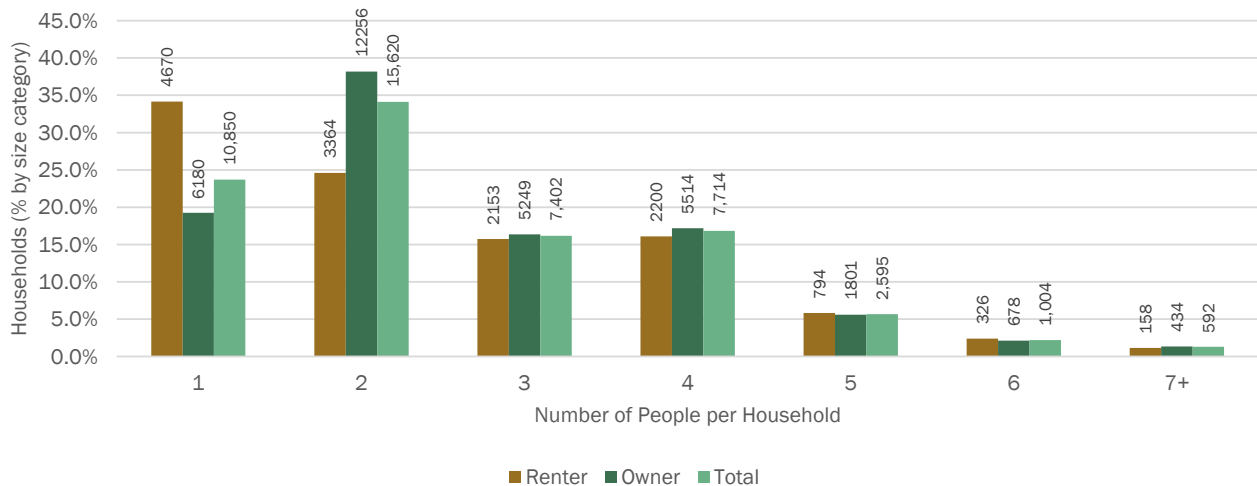

Across the SCAG region, the most common move-in period was 2010-2014 (31.9%) followed by 2000-2009 (26.1%). In Thousand Oaks, the period during which most people started living in their current residence was 2010-2014 (26.6%) followed by 2000-2009 (26.5%).

## II. SPECIALIZED HOUSEHOLD NEEDS: LARGE FAMILIES, SENIORS, AND FEMALE-HEADED

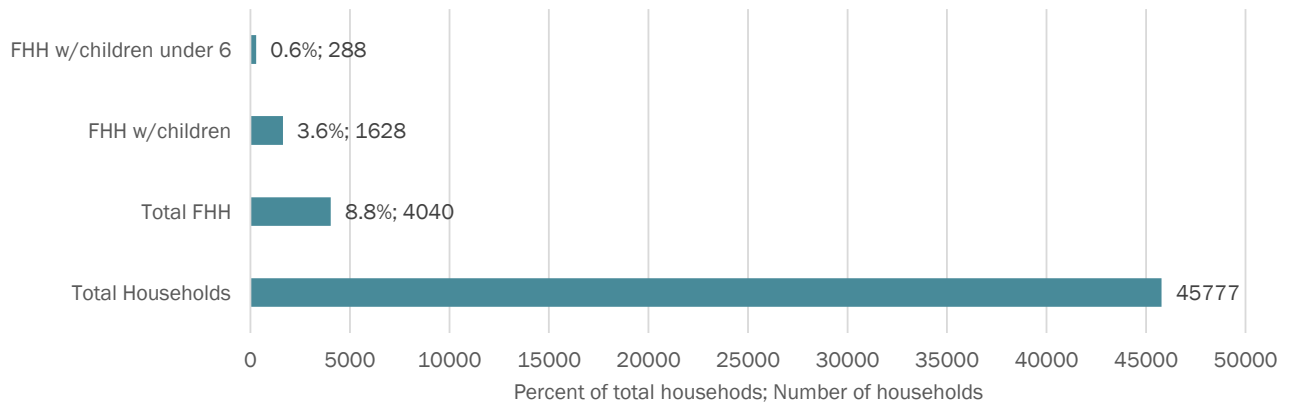
### Households by Household Size

This chart illustrates the range of household sizes in Thousand Oaks for owners, renters, and overall. The most commonly occurring household size is of two people (34.1%) and the second-most commonly occurring household is of one person (23.7%). Thousand Oaks has a higher share of single-person households than the SCAG region overall (23.7% vs. 23.4%) and a lower share of 7+ person households than the SCAG region overall (1.3% vs. 3.1%).

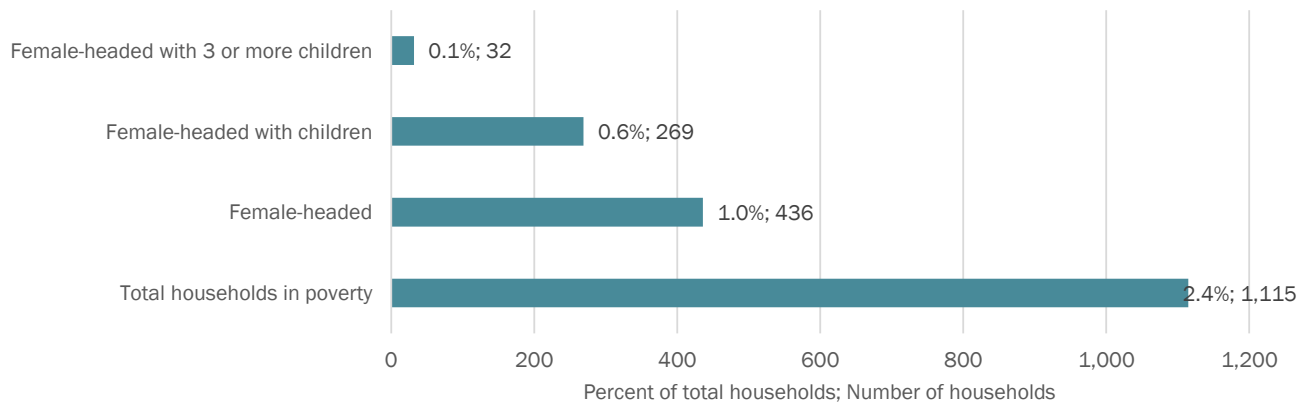
## Female Headed Households (FHH)

Statute requires analysis of specialized housing needs, including female-headed households in an effort to ensure adequate childcare or job training services. Of Thousand Oaks's 45,777 total households, 8.8% are female-headed (compared to 14.3% in the SCAG region), 3.6% are female-headed and with children (compared to 6.6% in the SCAG region), and 0.6% are female-headed and with children under 6 (compared to 1.0% in the SCAG region).

## Households by Poverty Status

2.4 percent of Thousand Oaks's households are experiencing poverty, compared to 7.9 percent of households in the SCAG region. Poverty thresholds, as defined by the ACS, vary by household type. More information can be found at M256. In 2018, a single individual under 65 was considered in poverty with a money income below \$13,064/year while the threshold for a family consisting of 2 adults and 2 children was \$25,465/year.



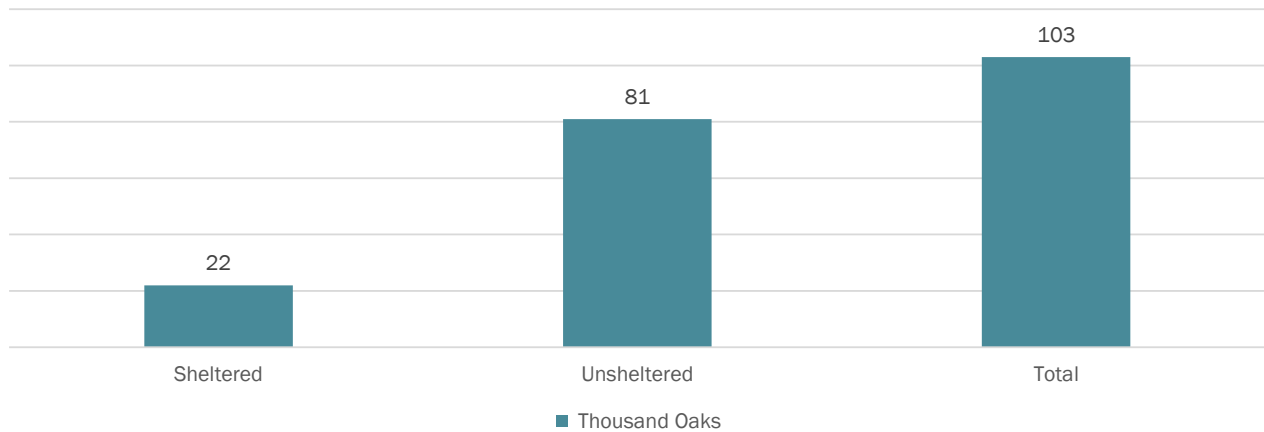

Statute requires analysis of specialized housing needs, including housing needs for seniors. Federal housing data define a household type as 'elderly family' if it consists of two persons with either or both age 62 or over. Of Thousand Oaks's 14,295 such households, 12.6% earn less than 30% of the surrounding area income, (compared to 24.2% in the SCAG region), 26.5% earn less than 50% of the surrounding area income (compared to 30.9% in the SCAG region).

### III. PEOPLE EXPERIENCING HOMELESSNESS

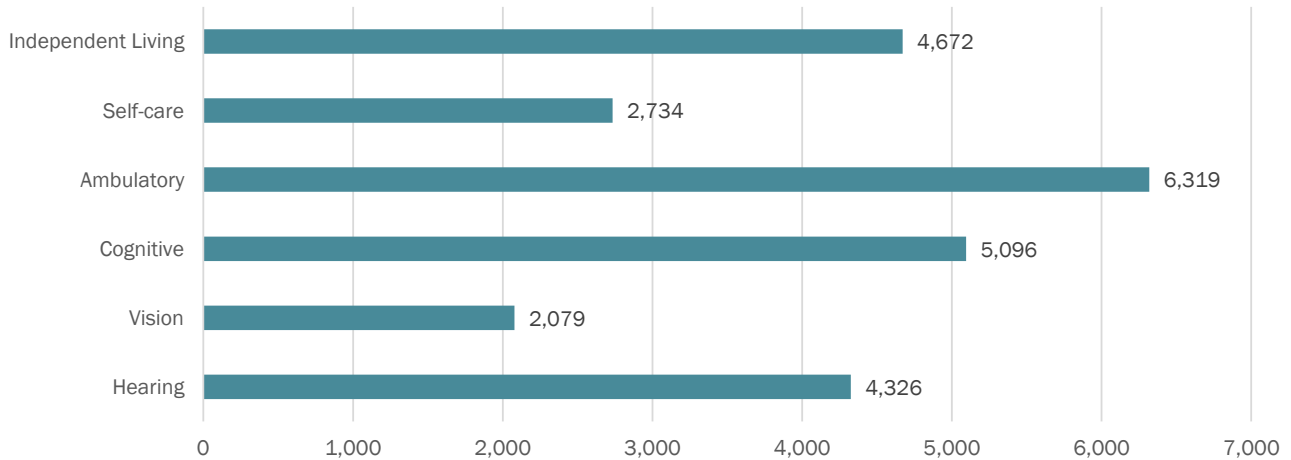

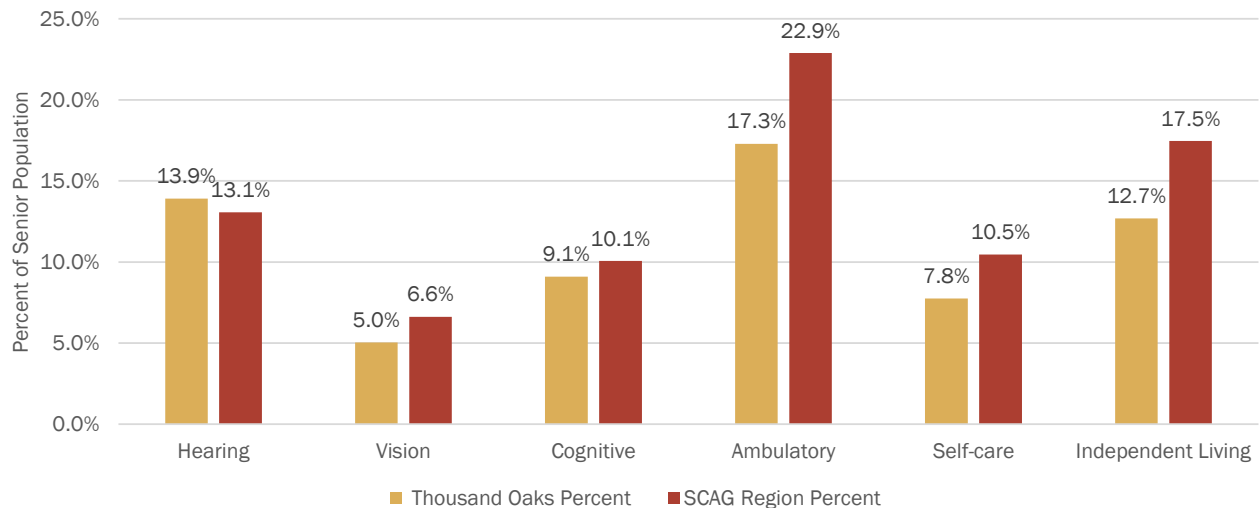
### Disability by Type

Disability data also provides valuable context for assessing current and future need for accessible housing units. Note that since some disability types are not recorded for children below a certain age, calculating disability as a percentage of total population may not be accurate.

In Thousand Oaks, the most commonly occurring disability amongst seniors 65 and older was an ambulatory disability, experienced by 17.3% of Thousand Oaks's seniors (and 22.9% of seniors in the SCAG region).

Understanding the employment status of people with disabilities may also be an important component in evaluating specialized housing needs. In Thousand Oaks, 45.4% of the population with a disability is employed, compared to 77.3% of the non-disabled population.

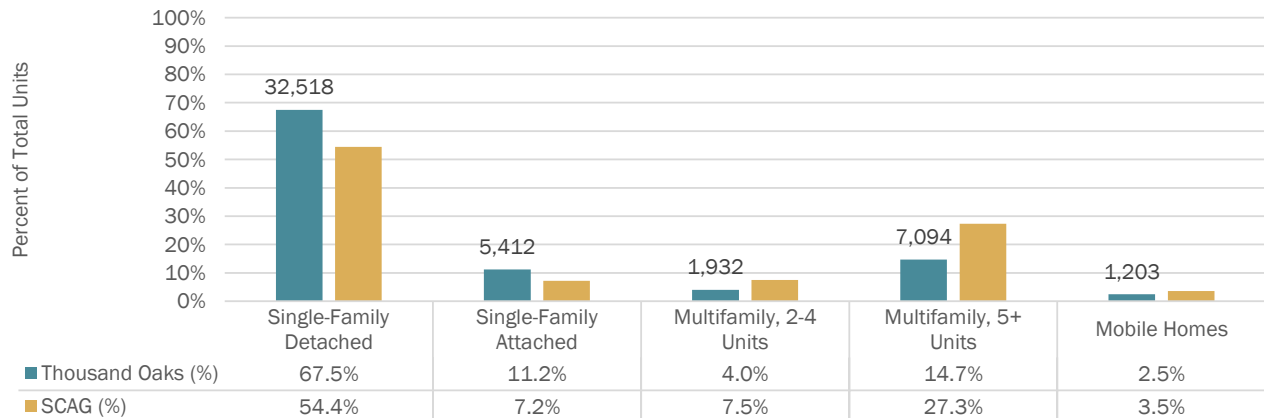

The California Department of Developmental Services also provides data on developmental disabilities by age and type of residence. These data are collected at the ZIP-code level and were joined to the jurisdiction-level by SCAG. Totals may not match as counts below 11 individuals are unavailable and some entries were not matched to a ZIP code necessitating approximation.

## V. HOUSING STOCK CHARACTERISTICS

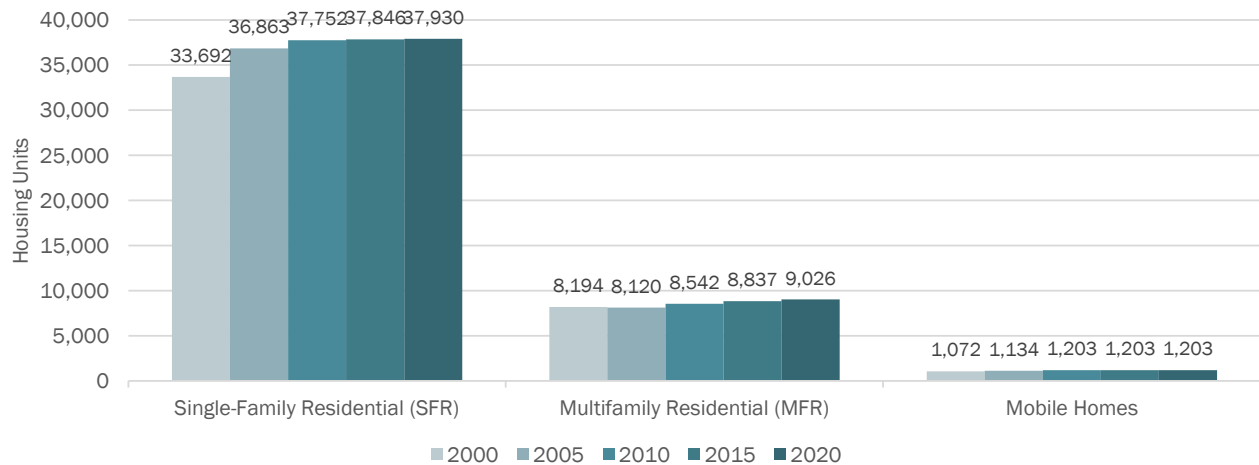
### Housing Type

The chart above provides detailed information on the housing stock in Thousand Oaks, which has a total of 48,159 housing units. The most prevalent housing type in Thousand Oaks is single-family detached with 32,518 units. The share of all single-family units in Thousand Oaks is 78.8%, which is higher than the 61.7% share in the SCAG region. Out of the total housing units in Thousand Oaks, there are 46,372 occupied-units, which equates to a 3.7% total vacancy rate. The average household size (as expressed by the population to housing unit ratio) is 2.69.

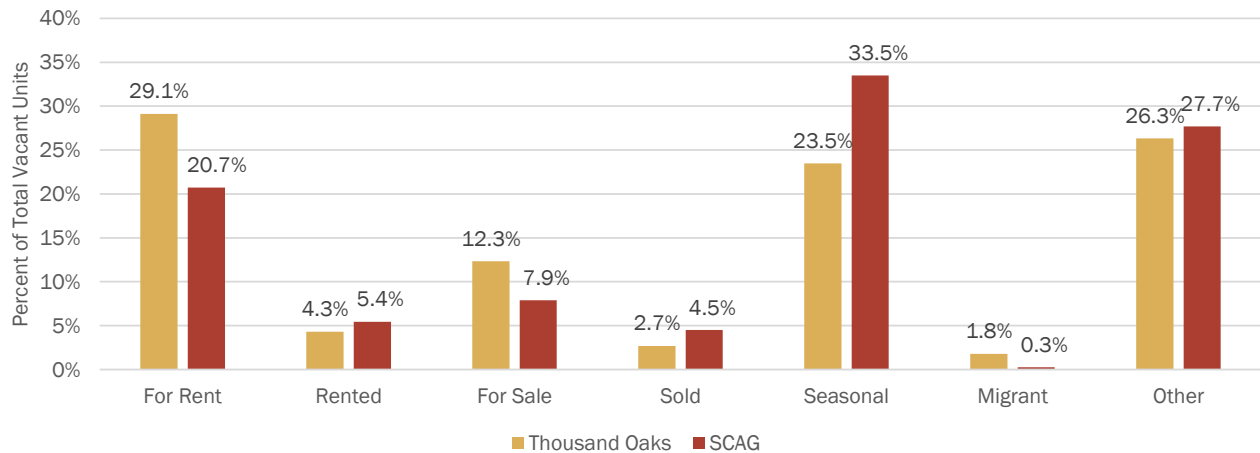
### Housing Type Trend

Over the past two decades (2000-2020), there has been more construction of single-family residential units than multi-family residential units in Thousand Oaks. When comparing 2000 to 2020, SFR units increased by 4,238, MFR units increased by 832, and mobile units increased by 131.

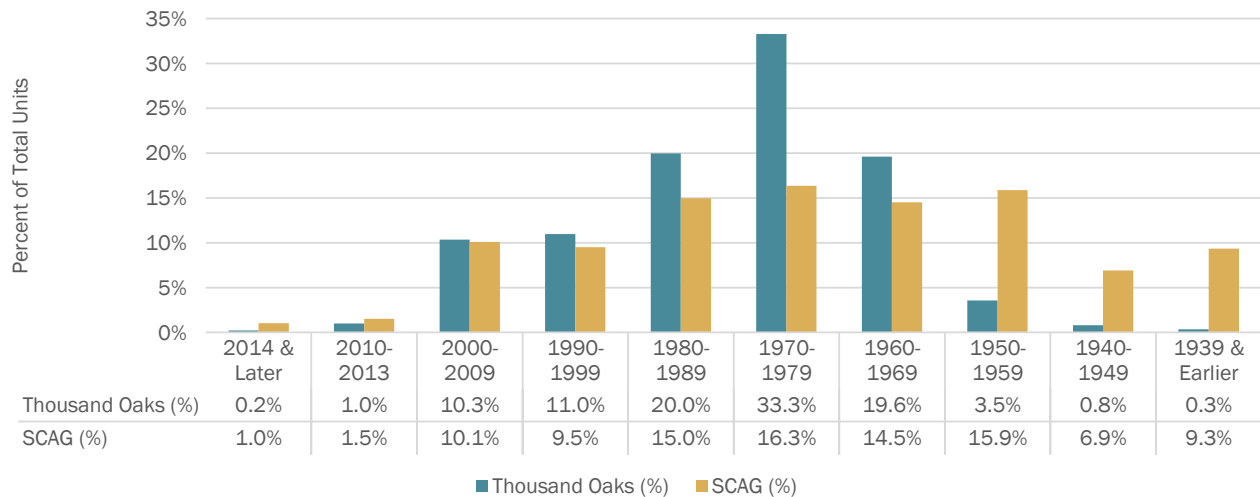
## Vacant Units by Type

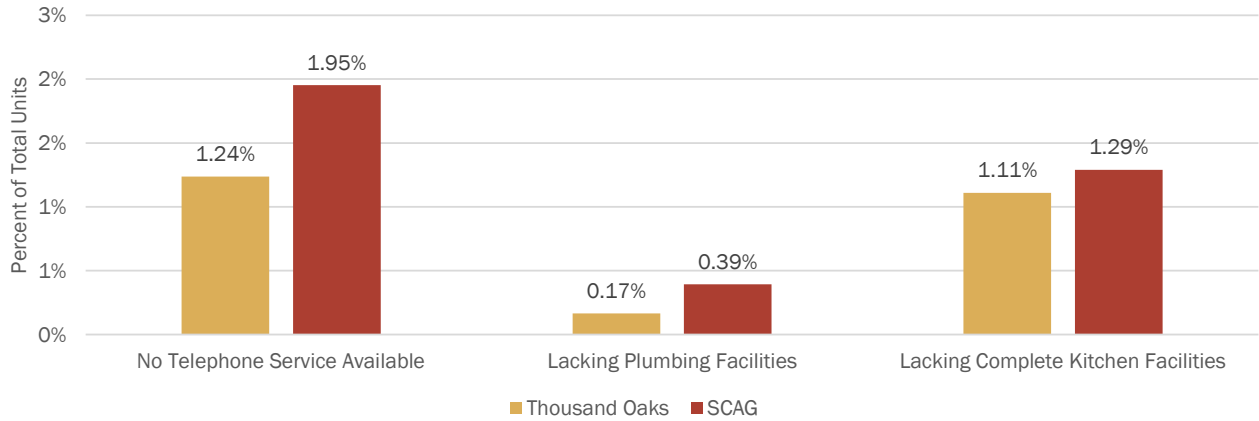
## Housing Units by Year Structure Built

Examining the age of the current housing stock is one way to understand how historical development patterns have contributed to a city's form. The time period where the highest share of Thousand Oaks's housing units were built is 1970-1979, while in the SCAG region more units were built during 1970-1979 than any other period.

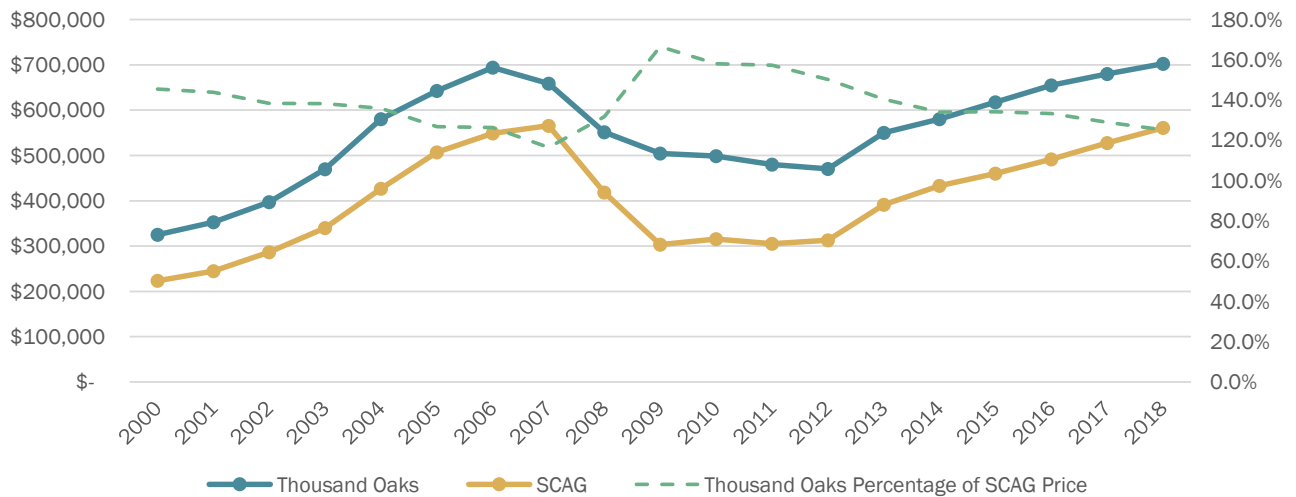
## Substandard Housing

The ACS includes surveys about three factors of what may be considered substandard housing. In Thousand Oaks, 566 units lack telephone service, 76 units lack plumbing facilities, and 508 units lack complete kitchen facilities.

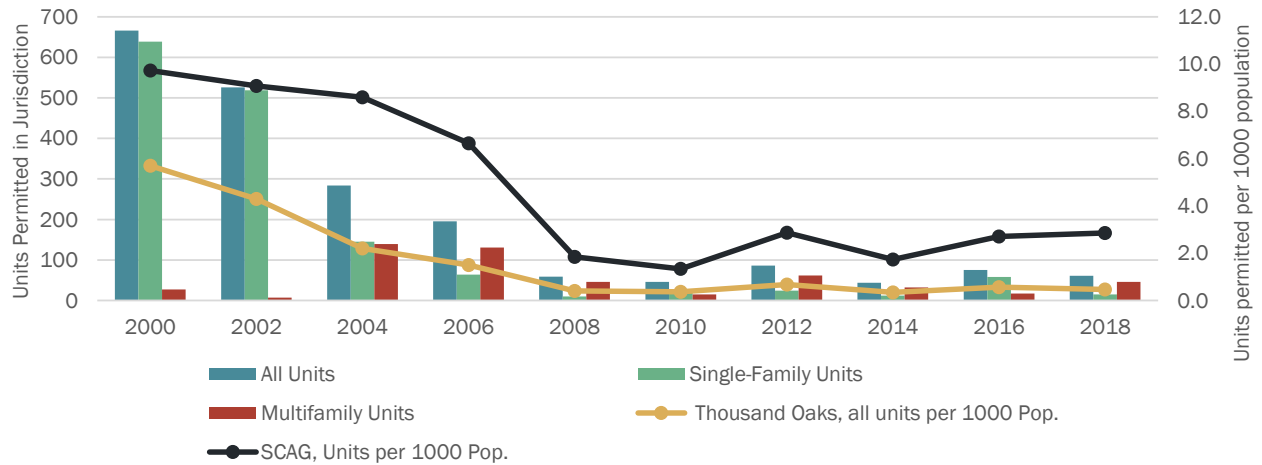
## Median Home Sales Price for Existing Homes

Between 2000 and 2018, median home sales prices in Thousand Oaks increased 116% while prices in the SCAG region increased 151%. 2018 median home sales prices in Thousand Oaks were \$702,500 and the highest experienced since 2000 was \$702,500 in 2018. Prices in Thousand Oaks have ranged from a low of 116.5% of the SCAG region median in 2007 and a high of 166.5% in 2009.

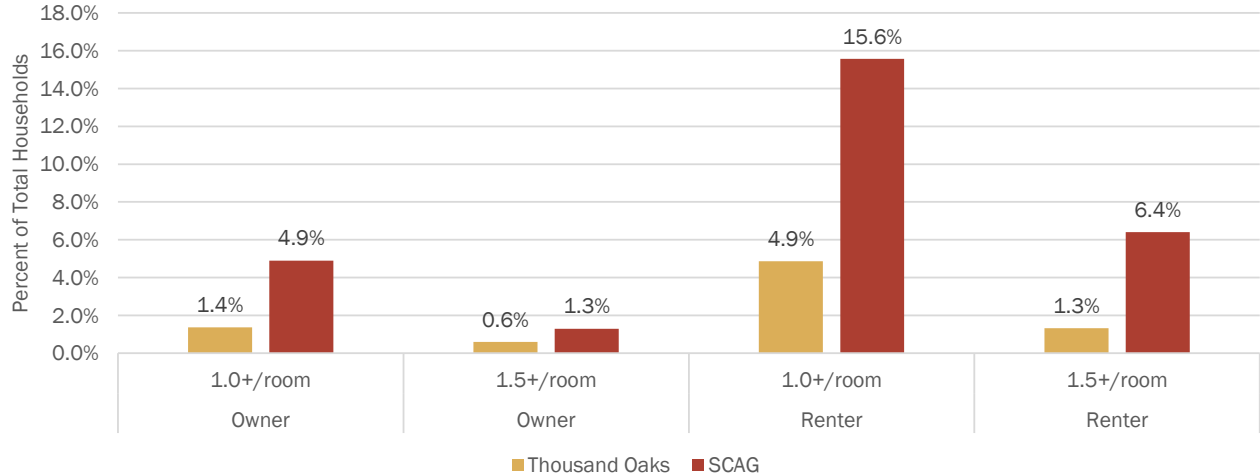
## Housing Units Permitted

## VI. OVERPAYMENT AND OVERCROWDING

### Crowding by Extent and Tenure

In Thousand Oaks, 437 owner-occupied and 664 renter-occupied households had more than 1.0 occupants per room, which meets the ACS definition for overcrowding. 190 owner-occupied households and 180 renter-occupied households had more than 1.5 occupants per room, which meets the ACS definition for severe overcrowding.

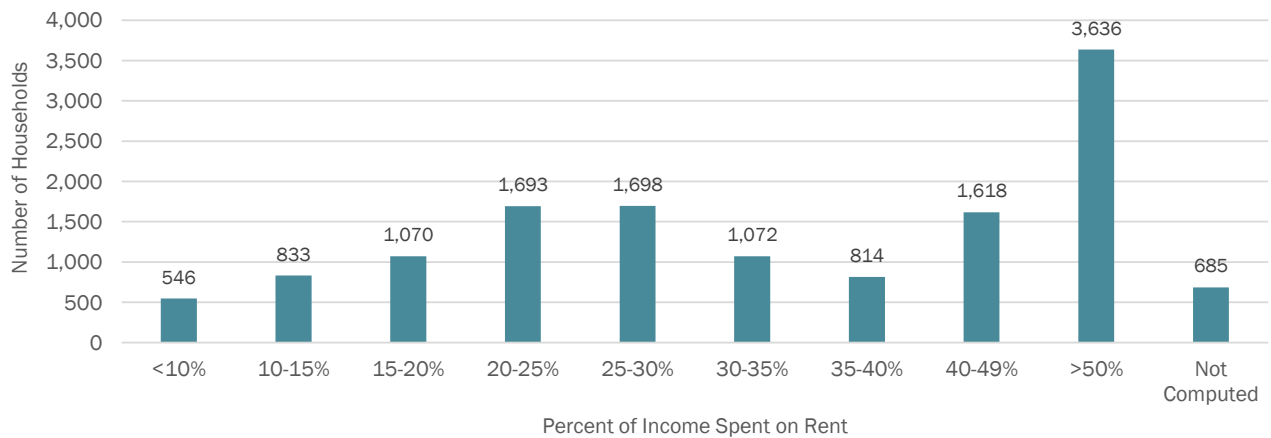

Housing cost burden is most commonly measured as the percentage of gross income spent on housing, with 30% a usual threshold for 'cost burden' and 50% the threshold for 'severe cost burden.' However, a lower-income household spending the same percent of income on housing as a higher-income household will likely experience more true 'cost burden.' These data indicate the number of households in Thousand Oaks by their income relative to the surrounding area and their share of income spent on housing.

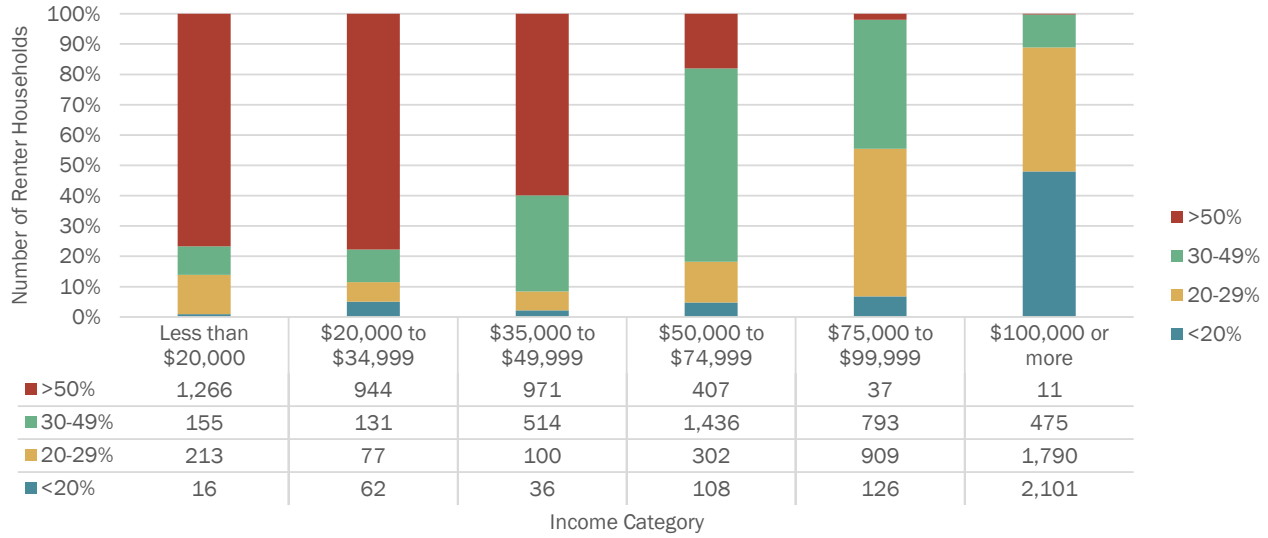
## Spending on Rent



Across Thousand Oaks's 13,665 renter households, 7,140 (52.3%) spend thirty percent or more of gross income on housing cost, compared to 55.3% in the SCAG region. Additionally, 3,636 renter households in Thousand Oaks (26.6%) spend fifty percent or more of gross income on housing cost, compared to 28.9% in the SCAG region.



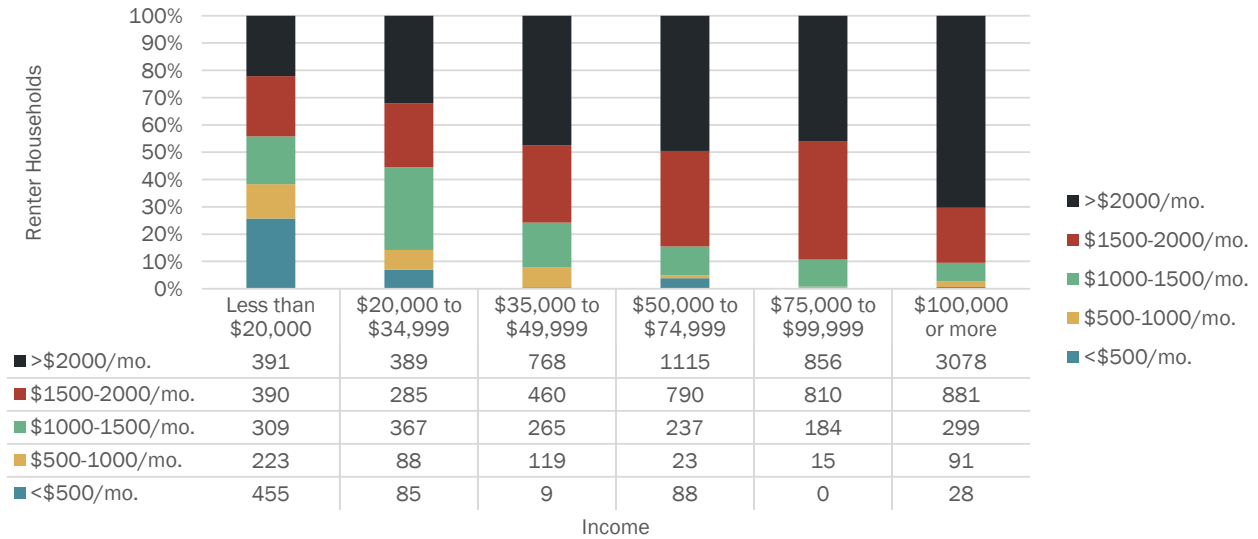
### Spending on Rent by Income

While the previous table breaks down cost burden by area-relative income, the ACS also allows for the analysis of Thousand Oaks's 12,980 renter households (for which income data are available) by spending on rent by income bracket (dollar amounts). As one might expect, the general trend is that low-income households spend a higher share of income on housing (e.g. over 50%) while high-income households are more likely to spend under 20% of income on housing.

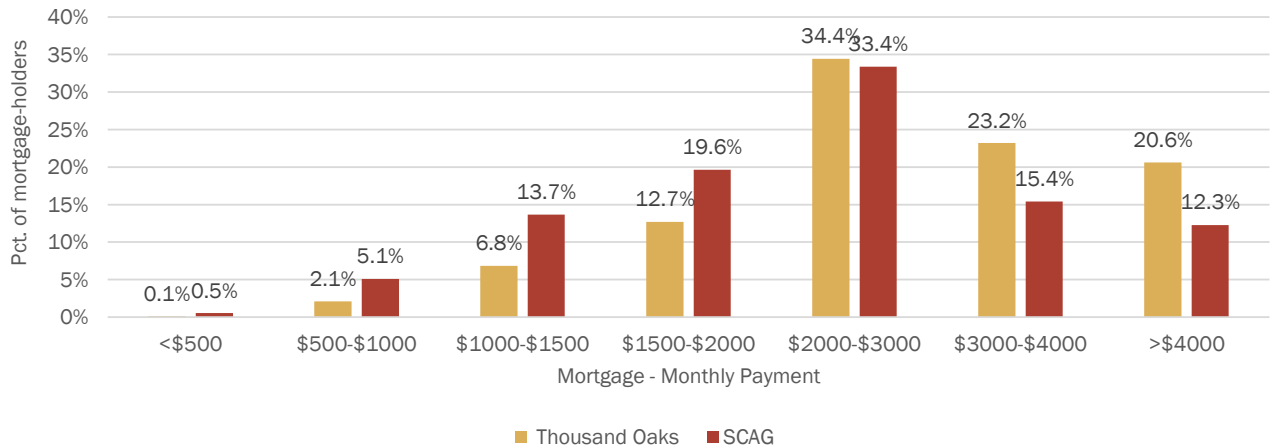
### Household Income by (Cash) Rent

Thousand Oaks renter households' cash rent paid can be broken down by household incomes. As one might expect, the general trend is that lower-income households spend less on rent while higher-income households spend more on rent, though this may not be universally true. Rent categories range from <\$500/month (5.1% of Thousand Oaks renters) to >\$2000/month (50.4% of Thousand Oaks renters). The most common rent category in Thousand Oaks is >\$2000/month with 50.4% of renters.

### Monthly Owner Costs for Mortgage Holders

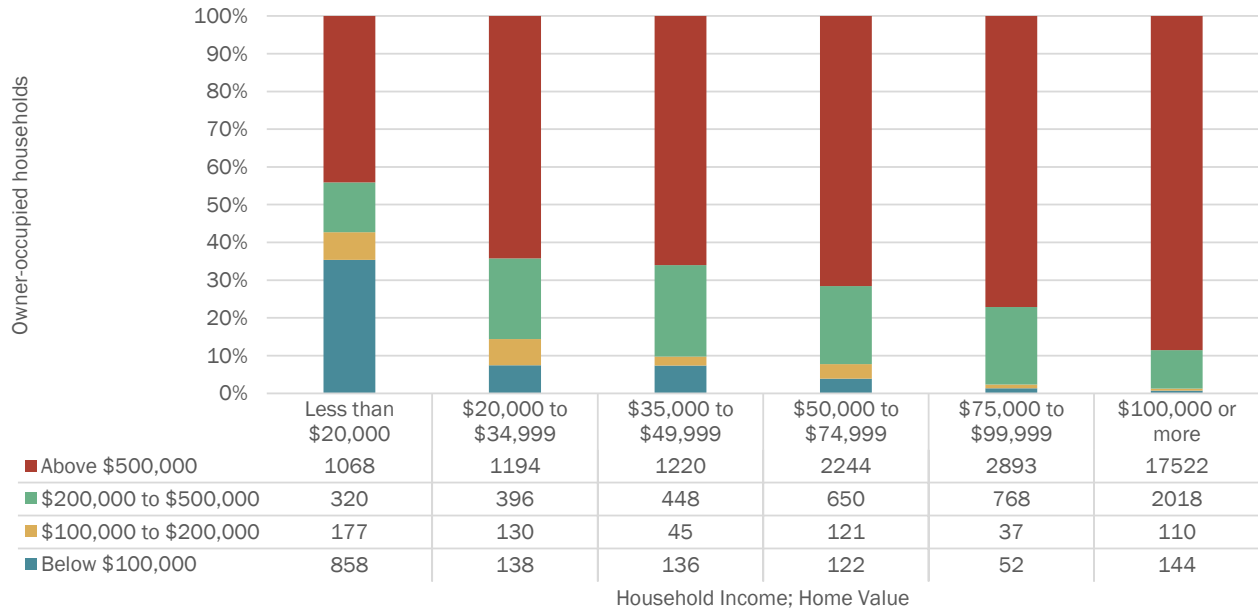
While renter households receive much of the focus when it comes to housing cost analysis, owner households make up 70.1% of Thousand Oaks and 52.5% of the SCAG region. The most commonly occurring mortgage payment in Thousand Oaks is \$2000-\$3000/month and the most commonly occurring mortgage payment in the SCAG region is \$2000-\$3000/mo.

### Costs for Mortgage Holders by Income



Mortgage-holding households in Thousand Oaks can be broken down by income and the percentage of income spent on mortgage costs. As one might expect, the general trend is that lower-income households spend a higher share of income on housing costs, while high-income households may spend a lower share of income on housing. The income category most prevalent amongst Thousand Oaks mortgage-holding households is \$75,000 or more (19,259 households) and the most prevalent share of income spent on mortgage costs is over 30% (9,054 households).

### Household Income by Home Value (for owned units)



Another approach to evaluating the relationship between housing and income is to compare incomes and home values in Thousand Oaks. The most commonly-occurring income category amongst owner households in Thousand Oaks is \$100,000 or more (19,794 households) and the most commonly-occurring home value category is Above \$500,000 (26,141 households).

Housing the extremely-low income population (below 30% of area median income) can be especially challenging. HUD's CHAS dataset provides a wealth of information on such households in Thousand Oaks. The above table provides a breakdown of extremely low income households by race and ethnicity. The race/ethnicity with the highest share of extremely-low income households in Thousand Oaks is Black, non-Hispanic (29.9% compared to 9.3% of total population). In the SCAG region, the highest share of extremely-low income households is Black, non-Hispanic (27.1% compared to 17.7% of total households).

The California Housing Partnership (CHP) provides data on assisted housing units and assesses the level of risk to converting to market rate. These data identify homes without a known overlapping subsidy that would extend affordability beyond the indicated timeframe and unless otherwise noted are not owned by a large/stable non-profit, mission-driven developer.
